The regular meeting of the Board of Adjustment having been properly noticed was called to order by Chair Dr. Frederick Rahe at 7:10 p.m. on Tuesday October 1, 2013. The pledge of allegiance followed. A roll call of the Board members was taken. There were no communications.

1) APPROVAL of the minutes from the August 8, 2013 Board of Adjustment meeting.
Mr. Schweitzer, seconded by Mr. DeCristofaro, made the following motion:

MOTION: SO MOVE TO APPROVE THE MINUTES AS PRESENTED

ROLL CALL: Mr. DeCristofaro, Yes; Mr. Schweitzer, Yes; Mr. Ahlbum, Yes; Dr. Rahe, Yes.
The motion passed with a 4 to 0 vote.

2) PERMISSION to operate a restaurant with a 2COP beer and wine license that is 934 feet from an existing child care center. Code requires a minimum separation of 1,000 feet between establishments licensed to serve alcohol for consumption on premises and child care facilities. Mr. Schweitzer, seconded by Mr. DeCristofaro, made the following motion:

The motion passed with a 4 to 0 vote.

3) PERMISSION to reduce the perimeter landscape buffer of a residential development from 25' in width to 10' in width. Code requires Planned Unit Develop (PUD) districts to provide a 25' wide peripheral setback from boundary lines of the PUD of not less than 25' in depth. Except for access ways, no portion of this peripheral setback may be used for parking or other vehicular use areas.

Mr. Schweitzer, seconded by Mr. DeCristofaro, made the following motion:

MOTION: SO MOVE TO APPROVE THE VARIANCE REQUEST AS REQUESTED BY
THE PETITIONER WITH THE CONDITION OF INSTALLING A CONNECTION
TO THE PARK AND INSTALLING INCREASED LANDSCAPING DURING
PHASE TWO OF THE PROJECT; IN PLACE OF A PERIMETER WALL.

The motion passed with a 4 to 0 vote.

The following motion was made by Mr. Ahlbum, seconded by Mr. Schweitzer:

4) PERMISSION to build a single story medical office building that will be 18 feet in height. Code requires a minimum of two enclosed floors of active use for new developments within the TOC Gateway district.
