Dear Mayor and City Officials:

The Broward County Human Services Department is the coordinating agency for the Edward Byrne Memorial Justice Assistance Grant-Countywide (JAG-C) program. This noncompetitive grant program is administered by the U.S. Department of Justice (DOJ), Office of Justice Programs (OJP), through the Florida Department of Law Enforcement (FDLE). Program funds can be used to support a broad range of crime prevention projects to improve the criminal justice system throughout our local communities. For the upcoming fiscal year, Broward County allocation of JAG-C funds is \$369,662.

In preparation for this funding round, we held a virtual informational session on February 27, 2025, with Mayors and City officials. During that meeting we announced that a survey would be developed to assess the needs in our communities. Results of the survey was used to drive the Federal Fiscal Year 2024 (FFY2024) process. Thank you to everyone who submitted the survey. Final approval of all JAG-C projects is under the purview of FDLE.

The selected countywide projects are listed on the attached sample letter of support (known as the "51% letters"). As required, the County must submit the 51% letters signed by Mayors of local units of government to FDLE. We respectfully request your support of the JAG-C projects by completing and signing the 51% letter.
