RESOLUTION NO. 21-016

A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, REQUESTING THE FLORIDA DEPARTMENT OF TRANSPORTATION TO CONTINUE DEVELOPMENT OF MOBILITY IMPROVEMENTS ALONG SW 11th STREET WITHIN CITY RIGHT OF WAY, FROM STATE ROAD 7 TO APPROXIMATELY SW 49th TERRACE; FURTHER EXPRESSING ITS INTENT TO TAKE OVER MAINTENANCE OF THE MOBILITY IMPROVEMENTS WITHIN THE CITY RIGHT OF WAY; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the State of Florida Department of Transportation (hereinafter FDOT) is authorized to undertake a project identified as Financial Project ID 429576-6, within Broward County's geographical limits; and

WHEREAS, pursuant to said project, FDOT agrees to provide mobility improvements along SW 11th Street from State Road 7 to SW 49th Terrace in Broward County; and

WHEREAS, the City desires to have installed the mobility improvements; and

WHEREAS, the City is willing to maintain the mobility improvements within City right of way after installation; and

WHEREAS, it is in the best interests of the City of Margate to approve and authorize an agreement to establish the mutual rights and obligations of the City and FDOT with respect to installation and maintenance of the mobility improvements pursuant to this project; and

WHEREAS, this project is on the Metropolitan Planning Organization (MPO) priority list as identified in the SR-7 Multimodal Improvement Corridor Study completed July 2016; and

WHEREAS, since this is an Off State Highway System Project, FDOT will not provide maintenance for the SW 11th Street mobility improvement project segment after construction is completed. A Maintenance Agreement will be required to establish the City as the maintaining agency for the proposed sidewalk segment and a Right of Way Certification; and

WHEREAS, pursuant to such authority, FDOT and the City are desirous of having the FDOT construct mobility improvements more

particularly described as Financial Project ID 429576-6, which involves constructing bike/mobility improvements along the project limits; and

WHEREAS, the parties hereto mutually recognize the need for entering into an Agreement designating and setting forth the responsibilities of each party;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

Section 1. The foregoing recitals are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. The City Council hereby requests FDOT to develop plans to construct mobility improvements along SW 11th Street from State Road 7 to approximately SW 49th Terrace, within City right of way to ensure continuity of mobility improvements.

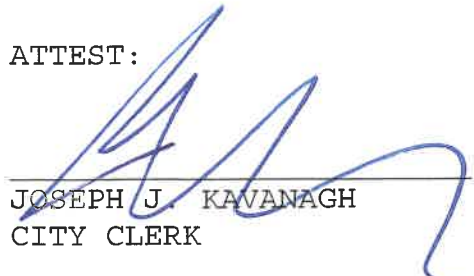

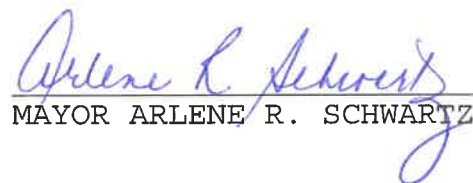
Section 4. The City Clerk is directed to provide a copy of this Resolution to FDOT.
