7 AMENDING CHAPTER 2 - ADMINISTRATION, ARTICLE I -
8 IN GENERAL, SECTION 2-11 - REQUESTS FOR
9 INFORMATION CONCERNING OUTSTANDING LIENS;
10 PROVIDING FOR FEES; PROVIDING FOR REPEAL;
11 PROVIDING FOR CODIFICATION; PROVIDING FOR
12 SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

16 BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE,
17 FLORIDA:

19 SECTION 1: The Code of Ordinances of the City of
20 Margate, Florida, Chapter 2 - Administration, Article I - In
21 General, Section 2-11, shall be amended to read as follows¹:
22

23 Sec. 2-11. - Requests for research and information concerning
24 outstanding city liens.

25 Whenever the city receives a request for an accounting of
26 the amounts of any outstanding city liens, ~~which requires~~
27 ~~clerical or supervisory assistance in excess of fifteen (15)~~
28 ~~minutes,~~ a minimum service fee of ~~twenty-five~~ seventy-five
29 dollars (\$~~75~~25.00) per request shall be charged to the person
30 making the request. For requests requiring rush service, to be
31 produced in one (1) business day, a minimum service fee of one
32 hundred fifty dollars (\$150.00) per request shall be charged to
33 the person making the request ~~for rush service.~~ Additional
34 charges at the rate of twenty-five dollars (\$25.00) per hour
35 shall be charged if the request requires more than one (1) hour
36 of staff ~~clerical~~-time.

38 SECTION 2: All ordinances or parts of ordinances in
39 conflict herewith are and the same is hereby repealed to the
40 extent of such conflict.

1 SECTION 3: If any section, sentence, clause, or phrase
2 of this ordinance is held to be invalid or unconstitutional by
3 a court of competent jurisdiction, then said holding shall in
4 no way affect the validity of the remaining portions of this
5 ordinance.

7 SECTION 4: It is the intention of the City Commission
8 that the provisions of this ordinance shall become and be made
9 a part of the City of Margate Code, and that the sections of
10 this ordinance may be renumbered or relettered and the word
11 "ordinance" may be changed to "section", "article" or such other
12 appropriate word or phrase in order to accomplish such
13 intentions.

15 SECTION 5: This ordinance shall become effective
16 immediately upon adoption.
