AN ORDINANCE OF THE CITY OF MARGATE,  
FLORIDA, AMENDING CHAPTER 9 - BUILDINGS,  
ARTICLE III - FEES, SECTION 9-21;  
PROVIDING FOR SEVERABILITY; PROVIDING FOR  
CODIFICATION; PROVIDING FOR AN EFFECTIVE  
DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF  
MARGATE, FLORIDA:

**SECTION 1:** CHAPTER 9 - BUILDINGS, ARTICLE III - FEES, is  
hereby amended to read as follows<sup>1</sup>:

Section 9-21. - Schedule of permit fees.

(1) Payment of fees required. Any person requiring a  
permit, in addition to any application therefor and before  
such permit is issued, shall pay all fees as required by  
this article. Permit and bond fees shall be determined in  
the manner set forth in this article. Permit fees for  
unscheduled improvements to property and installations  
shall be based on cost, pursuant to this section. City  
permit and bond fees shall be waived for permits issued for  
projects funded by the City of Margate general fund or City  
of Margate enterprise funds. Non-city permit fees in this  
article shall not be waived.

1           **SECTION 2:** All ordinances or parts of ordinances in  
2 conflict herewith are repealed to the extent of such conflict.

4           **SECTION 3:** If any section, sentence, clause, or phrase  
5 of this ordinance is held to be invalid or unconstitutional by  
6 a court of competent jurisdiction, then said holding shall in  
7 no way affect the validity of the remaining portions of this  
8 ordinance.

10           **SECTION 4:** It is the intention of the City Commission  
11 that the provisions of this ordinance shall become and be made  
12 a part of the City of Margate Code, and that the sections of  
13 this ordinance may be renumbered or relettered and the word  
14 "ordinance" may be changed to "section", "article" or such  
15 other appropriate word or phrase in order to accomplish such  
16 intentions.

18           **SECTION 5:** This ordinance shall become effective  
19 immediately upon adoption at its second reading.
