A RESOLUTION OF THE CITY OF MARGATE, FLORIDA APPROVING THE REVISED CITY OF MARGATE STATE PRIORITIES FOR THE 2025 LEGISLATIVE STATE LEGISLATIVE SESSION PREVIOUSLY APPROVED ΒY RESOLUTION 25-011; DIRECTING THE CITY CLERK TO SEND A COPY OF THE CITY OF MARGATE STATE LEGISLATIVE PRIORITIES FOR THE 2025 STATE LEGISLATIVE SESSION TO THE BROWARD COUNTY DELEGATION FOR CONSIDERATION; PROVIDING FOR THE ADMINISTRATION TO MOVE UP IN PRIORITY LISTED PROJECTS, BASED UPON RECOMMENDATION OF LOBBYIST, WITHOUT THE CITY'S FURTHER COMMISSION ACTION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Margate considers and follows federal, state, and local legislation that may affect the City and its residents; and

WHEREAS, the City of Margate has developed Legislative Priorities for the 2025 State Legislative Session outlining the City's position on particular legislative issues; and

WHEREAS, the City recommends that the revised City of Margate Legislative Priorities for the 2025 Legislative Session, previously approved by Resolution 25-011, attached hereto as Exhibit "A" and incorporated herein as a specific part of this Resolution, be forwarded to the Broward County Legislative Delegation; and

WHEREAS, the City Commission recognizes that legislative committee meetings, that have yet to be held, could impact the determination as to which projects will garner more consideration by the Florida Legislature in the 2025 legislative session; and

WHEREAS, the City Commission of the City of Margate deems it to be in the best interest of the citizens and residents of the City of Margate to approve the City of Margate State Legislative Priorities for the 2025 State Legislative Session.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

<u>Section 1</u>: That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2: That the City Commission of the City of Margate hereby approves the revised City of Margate State Legislative Priorities for the 2025 State Legislative Session attached hereto as Exhibit "A" and incorporated herein and made a specific part of this Resolution.

SECTION 3: That the Administration is authorized to move listed projects up in priority, based upon recommendation from the City's lobbyist, without further Commission action.

<u>Section 4</u>: That the City Manager is directed to provide a copy of this Resolution to the City's lobbyist to use throughout the 2025 legislative session.

<u>Section 5</u>: That the City Clerk is hereby directed to provide a certified copy of this Resolution to the Broward County Legislative Delegation for consideration.

SECTION 6: This Resolution shall become effective immediately upon its passage.
