Mr. Demming is correct that the attached Declaration of Restrictive Covenants (DRC), which is focused on arsenic contamination in and around the golf cart storage/maintenance garage building at the former Carolina Golf Club, details three types of restrictions (groundwater, soil, and land use). The DRC however, also includes language that allows the Declarant to modify these restrictions under certain circumstances with prior written approval from Broward County (EPD). In these instances, the Declarant must submit a plan to EPD for review and approval before any activity is initiated that may interfere with established controls or conflict with restrictions. Through this mechanism, any work that includes the movement of contaminated media can be overseen by the EPD to ensure that media is properly handled according to applicable state and county rules.

Please keep in mind that as County environmental regulators, we do not have influence over whether a specific development is permitted by a municipality; only that the development is conducted in a manner that does not cause harm to human health and the environment.

My title attorney then did a deep dive to see if any such Modification was ever completed AND recorded in Broward County Public Records. The title search found NO modifying document so that clearly means this this original Declaration of Restrictive Covenants is STILL IN FORCE!!

This Declaration states several Restrictions that clearly shows the Contaminated Property is a RISK to Public Health Safety. The Letter plainly states in paragraph 2.4 that "NO contaminated soil shall be removed from the contaminated property". This is because removing the Contaminated Soil would cause the poisoning toxins to become airborne thru dust and dirt and cover the surrounding area. This toxic dust will undoubtably expose everyone in the area to terrible health consequences.

Other Restrictive Covenants listed in the EPD Letter are as follows:

- There shall be no withdrawal of groundwater from the Contaminated Property Paragraph 2.1
- The Contaminated Soil shall remain permanently covered and maintained with impermeable material such as existing asphalt Paragraph 2.2
- The Contaminated Soil shall permanently be covered with 2 feet of clean and uncontaminated soil Paragraph 2.3
- -The Contaminated Property shall be used as Golf Course facility ONLY. NO RESIDENTIAL USES Paragraph 2.5

The Letter states many other things but the bottom lines is that this Contaminated Property undoubtably poses a terrible Public Health Risk to the entire community.

This proposed Rezoning request should absolutely be stopped!!
