CITY OF SUNRISE'S COMMISSIONER, JACQUELINE A. GUZMAN, spoke on this Item.

COMMISSIONER ARSERIO presented a plaque to Dr. Jonathan Fields and showcased a PowerPoint presentation displaying the shrubs and trees that he had donated to Margate and its residents.

MR. JONATHAN FIELDS made comment.

MAYOR RUZZANO highlighted next month's City's Kickball challenge of the Fire Department versus the Police Department.

2) PUBLIC DISCUSSION

JILL R. CERCHIONE, 6188 SEMINOLE TER., referenced the impropriety of Commissioner Caggiano's use of his title and questioned whether a new policy had been introduced.

COMMISSIONER ARSERIO said that he would address Ms. Cerchione's concerns in Commission Comments.

JULIE JONES read a statement pertaining to the last City Commission meeting and referenced Commissioner Caggiano.

STUDENTS FROM WEST BROWARD ACADEMY thanked the Mayor for his presence on Friday for celebrating their school choice prep-rally. They sought permission for the students to organize a community service project pertaining to Earth Day and requested tree donations.

COMMISSIONER ARSERIO advised that they should contact Parks and Recreation Director Jones

ROB REINER, 110 EAST PALM DRIVE, referenced the last City Commission meeting and questioned whether Vice Mayor Schwartz was going to condemn and censor Commissioner Caggiano.

VICE MAYOR ARLENE R. SCHWARTZ responded to Mr. Reiner's comments and said that she was not giving people political soundbites.

MAYOR RUZZANO highlighted the rules during Public Discussion. He also discussed intimidation.

ELSA J. SANCHEZ, 6930 NW 15TH STREET, said 'bravo' to Vice Mayor Schwartz's response. She discussed the forthcoming kickball competition between two City departments.

LAUREN BERACHA, 6950 NW 14TH PLACE, thanked the City Commission who responded to her email pertaining to feeling unsafe at the last meeting.

3) COMMISSION COMMENTS

COMMISSIONER JOANNE SIMONE congratulated those listed under the Presentations Item and to the Fields family for their very generous donation of trees.

COMMISSIONER ARSERIO confirmed that he had responded to resident, Ms. Beracha's email and made comment pertaining to the last City Commission meeting and people recording at meetings. He thanked the Police Department for conducting a Fraud Seminar and discussed the same. He also thanked Police Officer Wilmer and other officers who gave stuffed animals to underprivileged children. He informed that he would be utilizing some of his office account funds to help stock the police cars with stuffed animals and welcomed donations of unused toys. He discussed a fund raiser that he hosted for a pack where he did not use his City's job title and recommended that Margate should look into creating some type of policy and sought more information.

MAYOR RUZZANO discussed a complaint made by a former City Commissioner against him pertaining to a Christmas party he held in 2013. He explained that they asked for him to be censored and did not believe that such a policy should be implemented.

Discussion ensued.

VICE MAYOR SCHWARTZ referenced stuffed animals, highlighted this weekend's Sounds at Sundown event and Valentine's Day next month.

MAYOR RUZZANO informed that City Manager Curtis would be looking into organizing a Tree Giveaway event.

COMMISSIONER ARSERIO explained that the City and the CRA had very successful grant programs and discussed how it affected Homeowners Associations (HOA) and condo associations that applied for the same. He requested if a Property Improvement Grant Program (PIP) could be separate and specific to HoAs and considered and placed on a future City Commission Agenda. He suggested improvements could be

implemented for clubhouse hardening, entry way signs and perimeter landscapes.

VICE MAYOR SCHWARTZ indicated that there were other grant programs available but no one took advantage of them.

Discussion ensued on how the PIP would improve on curb appeal and increase value in real estate.

MAYOR RUZZANO consented to Commissioner Arserio's suggestion about PIP.

4) CITY MANAGER'S REPORT

CITY MANAGER CALE CURTIS provided an update on the PIP and informed that they had approved applications to exhaust round two of the funding. He advised that eight applicants were denied and 62 had been approved for a total of \$500,000. He explained that the City still had money reserved for the round one list of applicants which were in some form of holding pattern. He said that he would work with the City Commission on recommendations of either a third round, some sort of expansion of the second round or a completely new program specific to HoAs. He recognized the exemplary work performed by the Water Distribution team in the Department of Environmental and Engineering Services (DEES) and referenced the recent respective water breaks on Margate Boulevard and East River Drive.

[Appendix A – Zoning – Section 3.3] Any representation made before any City Board, any Administrative Board, or the City Commission in the application for a variance, special exception, conditional use or request for any other permit shall be deemed a condition of the granting of the permit. Should any representation be false or should said representation not be continued as represented, same shall be deemed a violation of the permit and a violation of this section.
