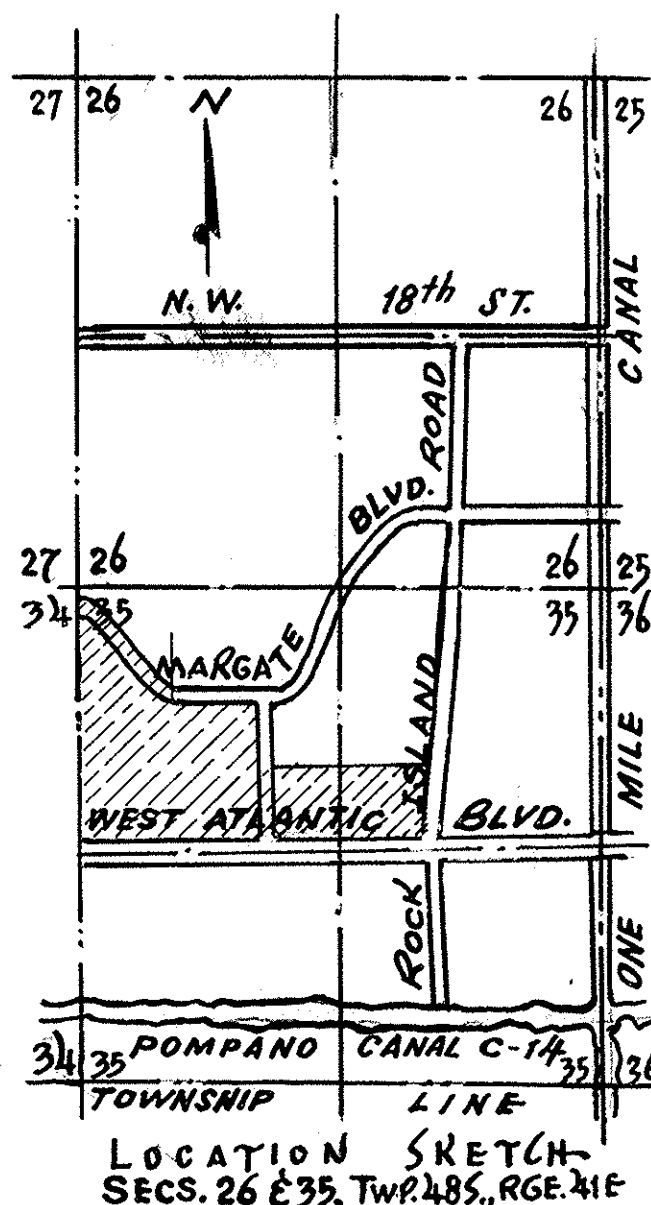

DESCRIPTION

A portion of Section 35, Township 48 South, Range 41 East, Broward County Florida, described as follows: Commencing at the North West Corner of said Section 35 run S 0°03'23"W along the West boundary of said Section 35 a distance of 186.60 feet to the Point of Beginning. Thence S 89°56'37"E a distance of 15.94 feet to the Point of Curve of a curve to the right having a Radius of 770.05 feet and Central Angle of 39°51'40"; thence Southeasterly along the Arc of said Curve a distance of 535.73 feet to the Point of Tangent; thence S 50°04'37"E a distance of 725.16 feet to the Point of Curve of a curve to the left having a Radius of 670.33 feet; thence Southeasterly along the Arc of said curve, through a Central Angle of 4°12'48", a distance of 49.29 feet to a point on the West boundary of "ORIOLE GOLF AND TENNIS CLUB SECTION ONE", recorded in Plat Book 75, Page 34, Public Records of Broward County, Florida; thence S 0°22'34"E along said West boundary a distance of 126.71 feet to a point on a Curve concave Northeastly having a Radius of 776.33 feet, a tangent line from which bears S 59°48'42"E; thence Southeasterly and Easterly along the South boundary of said "ORIOLE GOLF AND TENNIS CLUB SECTION ONE" the following three courses and distances: Southeast-erly along the arc of said curve of 776.33 foot radius, through a central angle of 29°48'45", a distance of 403.95 feet to the Point of Tangent; thence S 89°37'27"E, a distance of 667.03 feet to the Point of Curve of a curve to the left having a radius of 769.01 feet; thence Easterly along the arc of said curve, through a Central Angle of 1°11'54", a distance of 16.08 feet to the Point of Reverse Curve of a curve to the right having a Radius of 25 feet and Point of Termination of the said three courses and distances; thence Southeasterly along the arc of said curve, through a Central Angle of 91°52'56", a distance of 40.09 feet to the Point of Tangent, said Point being on the West R/W Line of N. W. 76th AVENUE; thence S 10°33'55"W along the said R/W Line, a distance of 745.33 feet to the S.W. Corner of "PARADISE GARDENS, SECTION 4", recorded in Plat Book 76, Page 8, Public Records of Broward County, Florida; thence S 89°41'21"E, a distance of 1,629.56 feet to the S.E. Corner of said "PARADISE GARDENS, SECTION FOUR", said Corner being on the West R/W Line of ROCK ISLAND ROAD, and on a Curve having a Radius of 2,367.68 feet, a tangent line from which bears S 7°49'21"W; thence Southerly along said curve and said West R/W Line, through a Central Angle of 9°28'59", a distance of 391.88 feet to the Point of Tan-gent; thence S 1°39'38"E along the said West R/W Line, a distance of 531.67 feet to a Point on the North R/W Line of WEST ATLANTIC BOULEVARD (LYONS ROAD), said Point being 4.58 feet North of the East-West quarter Line of aforementioned SECTION 35; thence N 88°56'25"W along said North R/W Line a distance of 3,822.27 feet to a point on the West boundary of said SECTION 35 that is 14.92 feet South of the West 1/4 Corner thereof; thence N 0°03'23"E along the said West boundary a distance of 2,542.48 feet to the POINT OF BEGINNING.
