AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA,
AMENDING ARTICLE 5 - ZONING, DIVISION 3 -
BUSINESS DISTRICTS, SECTION 40.520 -
NEIGHBORHOOD BUSINESS: B-1, DIVISION 6
PLANNED AND MIXED USED DISTRICTS SECTION
40.552 - CORRIDOR: C AND SECTION 40.553-
GATEWAY: G, OF THE CITY OF MARGATE CODE OF
ORDINANCES; PROVIDING FOR PET DAYCARE ZONING
LIMITATIONS AND REQUIREMENTS; PROVIDING FOR
CONFLICT; PROVIDING FOR SEVERABILITY;
PROVIDING FOR CODIFICATION; PROVIDING FOR AN
EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF
MARGATE, FLORIDA:

Section 1: Article 5 - Zoning, Division 3 -
Business Districts, Section 40.520 - Neighborhood Business:
B-1, of the City of Margate Code of Ordinances, be, and the
same is hereby amended to read as follows:

40.520. Neighborhood Business: B-1.

structure, or part thereof, shall be erected, altered or
used, or land or water used, in whole or in part, for other
than one (1) of the following specified uses:

367. Vending machine (outdoor), permitted as an accessory use to a permitted use and subject to the limitations contained in Section 40.621, Vending machine (outdoor).

378. Walkway cafes less than one thousand (1,000) square feet in area subject to the requirements in section 40.622 of this Code.

Section 2: Article 5 - Zoning, Division 6 Planned And Mixed Used Districts, Section 40.552 - Corridor: C, of the City of Margate Code of Ordinances, be, and the same is hereby amended to read as follows:

40.552. Corridor: C.

(E) *Corridor permitted uses.* No building or structure, or part thereof, shall be erected, altered or used, or land or water used, in whole or in part, for other than any of the uses specified below. All minimum separation distances shall be measured in the shortest airline distance between nearest property lines unless otherwise specified.

40.553. Gateway: G.

(A) *Permitted uses.* No building or structure, or part thereof, shall be erected, altered or used, or land or water used, in whole or in part, for other than any of the uses specified below. All minimum separation distances shall be measured in the shortest airline distance between nearest property lines unless otherwise specified.

24 unconstitutional by a court of competent jurisdiction, then

25 said holding shall in no way affect the validity of the

26 remaining portions of this Ordinance.

28 **SECTION 6:** It is the intention of the City

29 Commission that the provisions of this Ordinance shall become

30 and be made a part of the City of Margate Code, and that the

31 sections of this Ordinance may be renumbered or relettered

32 and the word "ordinance" may be changed to "section",

33 "article" or such other appropriate word or phrase in order

34 to accomplish such intentions.

36 **SECTION 7:** This Ordinance shall become effective

37 immediately upon adoption at its second reading.
