Dear Mayors and City Officials:

The Edward Byrne Memorial Justice Assistance Grant-Countywide (JAG-C) is a program administered by the U.S. Department of Justice (DOJ), Office of Justice Programs (OJP) and in Florida by the Florida Department of Law Enforcement (FDLE). Program funds can be used to support a broad range of activities to prevent and control crime and to improve the criminal justice system throughout the County.

The Broward County Human Services Department, Community Partnerships Division, issued a Request for Proposals (RFP) on May 1, 2017 for program funding that included one initial year and two renewal option periods. Following submission of grant proposals, a comprehensive review process was conducted using a rating committee comprised of County staff, community stakeholders and volunteers, many of whom had reviewed JAG-C proposals previously. The attached letter includes the resulting recommendations, which will be presented for approval by the Broward County Board of County Commissioners. Final approval of the JAG-C projects is under the purview of FDLE.

For the federal fiscal year 2018-2019, Broward County will utilize the \$412,043 in JAG-C funds for the first option period of the program awarded in the 2017 RFP. In order to continue this funding, we must submit to FDLE supporting letters (known as "51% letters") from the Mayors of local units of government. The 51% letters must represent at least 51% of the units of government, which also represent at least 51% of the population located in the county. **These "51% letters" are required by FDLE as part of the JAG-C application process.** Please print the 51% letter on your letterhead and have it signed by the Mayor. A sample letter is attached for your convenience. **Please return a scanned copy of the signed letter via email to my attention by July 13, 2019.**

PLEASE DO NOT SEND THE LETTER DIRECTLY TO RONA KAY CRADIT. Please note: if someone other than the Mayor signs the letter, FDLE requires an additional document indicating this person's signatory authority.
