SUBJECT: **Consideration to Upgrade Holsters / Active Shooter Kits**

Holsters:

Officers were previously issued a Safariland model 6280 Level II holster. We are now issuing new hires the Level III holster. I recommend that we upgrade the entire department's issued holster to a level III holster. This upgrade will allow our officers an added layer of security for retention of their issued firearm. The level III adds a thumb-break style release before a weapon can be drawn.

The Special Response Team are all issued the Level III holster and I feel that all officers should be afforded this added layer of safety for the retention of their firearm.

A breakdown of the cost is as follows:

109 Sworn Officers (- 15 SRT Operators who are already equipped with a level III) = 94 (+ 10 for new hires and spares)

Level II Cost = \$109.00 each x 104

Level III Cost = \$119.00 each x 104

Recommended total expenditure for holster

\$12,376

If this is approved, I recommend purchasing as soon as possible to incorporate the new holster into our upcoming firearms training and weapons retention DT Training.

A proposal was previously submitted in February of 2017 for critical incident/active shooter and medical equipment. This equipment will provide an added level of safety to officers responding to a critical incident/active shooter situation. I requested MPO Pellegrino update the quotes obtained previously and the figures are as follows:

Ballistic helmets, Rifle Plates and Carrier, "Police" ID labels	\$61,525.00
Rifle and Glock extended magazine (2 per officer)	\$9,670.00
5.11 bail out bag (to carry the kit)	\$5,060.00
Tourniquet, chest seals, trauma dressing, and hemostatic bandage	\$7,596.50

Total for Crisis Kits: \$83,851.50

The total requested expenditure for the Crisis Kits and Holsters is - **\$96,227.50**
