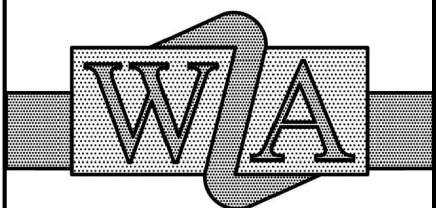


SITE PLAN LEGEND
