- Dive existing Lap pool, put (2) 10" inflatable plugs in the main drain lines. Install 2" expandable plug in the existing equalizer line. This is will enable us to remove the existing collector tank and build the new concrete tank without having to drain the entire Lap pool.
- Remove the existing 390 gallon fiberglass collector tank for the Lap pool and haul away.
- Excavate approximately 2' around the old collector tank in order to form new tank.
- Compact ground properly to ensure no future settling. Install approx. 6" of 57 rock.
- Form, steel, and pour new concrete collector tank using existing plumbing. New tank will be a minimum of 400 gallons.
- Install water stops over the existing plumbing that penetrates through the new concrete collector
- New concrete collector tank will be poured in place over existing plumbing.
- We will thoroughly waterproof the collector tank with Basecrete waterproofing system.
- New collector tank with have new slide valves for gutter and main drain.
- Install new auto fill, new custom top with open grating and lid for access just like we did for City of Tamarac (see attached photo). The new collector tank will be slightly bigger and will come out of the ground approximately 12" above grade.
- This proposal includes the necessary permits for HRS modification and City permits if needed.
