

## SPECIFIC MANAGEMENT APPROACH

We developed a flat rate program for fleet accounts, which allows for more timely cost effective management. A quick turn around time is crucial to the efficiency of the fleet.

The City of Margate is a major fleet and we have experience with servicing the body shop repair needs over the last three years. We will continue to place our best effort for the City of Margate's parts and repairs to be performed as a priority and with quality repairs.

- (a) Collision and body shop repair is one of the most critical elements in optimizing and maintaining a fleet, especially for a municipality servicing their community. By implementing a priority turn-around plan for fleet vehicles and equipment, and minimizing disruption to the fleet. In addition to implementing the plan, we will be properly purchasing parts inventory to maximize the efficiency of the repair, and minimize the downtime of the fleet vehicle when it is in the shop.
- (b) The fleet repair shop will be appropriately staffed to meet the demands of the fleet. All Body Shop staff will be available to perform services to the City of Margate's fleet as needed. The repair shop will be equipped with the necessary state of the art tools to perform body shop repairs. Joey Accardi strives to keep the repair facility up to date with advanced technology and state of the art tools.
- (c) Pathways estimated system is used to generate the estimates for the repairs of the fleet vehicle. Final invoices are provided to the City of Margate for each unit at the time of completion.
- (d) The shop is fully equipped with computer technology, custom mixology paint booth, frame machines, and the latest downdraft heated spray and paint booths.

By CITY proceeding with the repair after such disclosure from the Contractor, CITY accepts the time frame set forth on the repair estimate and will not expect vehicle to be ready in 7 calendar days.

\*The City reserves the right to make multiple awards as it sees fit.

Points will be based on the following formula in the Price Category of the Evaluation Criteria.

All labor and paint materials will be added and averaged.

The parts markup will be given a value based on % of markup submitted.

Lowest % of markup will be given \$0 dollars. Next lowest markup will be given \$1 dollar and so on.
