AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA, CHAPTER 2 ADMINISTRATION, AMENDING ARTICLE IV - BOARDS, COMMITTEES, ETC., DIVISION 2 - BOARD OF ADJUSTMENT, SECTION 2-76 AND DIVISION 3- PLANNING AND ZONING BOARD, SECTION 2-86; PROVIDING FOR APPOINTMENTS FOR A ONE YEAR PERIOD CONSISTENT WITH SECTION 2-73; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: The Code of Ordinances of the City of Margate, Florida, Chapter 2. Administration, Article IV, Division 2-Board of Adjustment, Section 2-76, is hereby amended to read as follows¹:

Sec. 2-76. - Created; appointment; terms; officers; advisors.

A Board of Aadjustment for the Ceity is hereby created and established consisting of five ~~(5)~~ members who shall be qualified as Board members as provided by law. The Board members shall be appointed by the Ceity Ceommission and shall serve without compensation and at the pleasure of said Ceity Ceommission. All appointments shall be for a one~~two~~ year period. The members of said Board shall elect a chairperson, a vice-chairperson, and a secretary from its membership. The Ceity Manager, Ceity building inspector, Ceity Attorney and such other officers and officials of the Ceity as the Board may require shall be considered as

1 advisors to the Ceity Board of Aadjustment and may be
2 called upon from time to time to meet with said Board.

4 **SECTION 2:** The Code of Ordinances of the City of
5 Margate, Florida, Chapter 2. Administration, Division 3-
6 Planning and Zoning Board, Section 2-86, is hereby amended
7 to read as follows:

8 Sec. 2-86. - Creation; appointment; terms; officers;
9 advisors.

10 A Ceity Planning and Zoning Board for the City of
11 Margate is hereby created and established, consisting of
12 five ~~(5)~~ members. The ~~said~~ Board members shall be
13 appointed by the Ceity Commissioners, and shall serve
14 without compensation and at the pleasure of said Ceity
15 Commission.

16 All appointments shall be for a ~~one~~two- year period.

17 The members of the said Board shall elect a chairman, a
18 vice chairman, and a secretary from its membership.

19 The Ceity Manager, Ceity building inspector, Ceity
20 Attorney, and such other officers and officials of the
21 Ceity as the Board may require, shall be considered as
22 advisors to the Ceity Planning and Zoning Board and may
23 be called upon from time to time to meet with said Board.

25 **SECTION 3:** All ordinances or parts of ordinances in
26 conflict are repealed to the extent of such conflict.

28 **SECTION 4:** If any section, sentence, clause, or
29 phrase of this Ordinance is held to be invalid or
30 unconstitutional by a court of competent jurisdiction, then
31 said holding shall in no way affect the validity of the
32 remaining portions of this Ordinance.

34 **SECTION 5:** It is the intention of the City
35 Commission that the provisions of this Ordinance shall
36 become and be made a part of the City of Margate Code, and
37 that the sections of this Ordinance may be renumbered or
38 relettered and the word "ordinance" may be changed to
39 "section", "article" or such other appropriate word or
40 phrase in order to accomplish such intentions.
