CALL TO ORDER

DISTRICT 96 – FLORIDA STATE REPRESENTATIVE CHRISTINE HUNSCHOFSKY thanked the City for their partnership and for their support. She gave a brief update where she highlighted five bills that were filed this session which included:

- School Safety bill;
- Flood Disclosure;
- Shielding information when you sign up to the Broward County Property Appraiser's (BCPA) Owner Alert program; and
- My Safe Florida Home Condominium pilot program and she listed the application dates for July and August 2024.

DISTRICT 96 – FLORIDA STATE REPRESENTATIVE HUNSCHOFSKY also briefly discussed a sixth bill that she filed last session pertaining to workforce. She advised that two of the Margate projects for the Radio Tower Repair and Upgrades for \$300,000 and

the Margate Frontline Rescue and Aerial Truck for \$372,000, were currently included in the budget which had not gone to Governor Ronald DeSantis as yet. She explained that the Broward County (BC) projects of the \$700,000 budgeted Junior Achievement of South Florida Youth Workforce Program expansion and a budget of \$600,000 for the Eagles Haven Wellness Center impacted Margate residents. She discussed the missed opportunities for this legislative session and indicated that there was no substantive action on property insurance but they would continue to advocate for that and she discussed the Vacation Rental bill. She introduced some of her high school interns and encouraged students to apply to their program and learn about civics.

MAYOR TOMMY RUZZANO expressed his gratitude to Florida State Representative Hunschofsky.

Discussion ensued on the time frame that State Governor DeSantis would veto the bills.

2) PUBLIC DISCUSSION

MARGATE RESIDENT, DENISE C. WHITLEY, moved from New Jersey to Florida four years ago and questioned whether the Citizen's Academy (CA) that used to be on the City's website would be reinstated.

Discussion ensued.

MAYOR RUZZANO indicated that a couple of residents had talked about the CA and suggested that the City Commission could raise this when they had their one-to-one

meetings if they wanted to do it again.

VICE MAYOR ARLENE R. SCHWARTZ confirmed that the CA was suspended due to the Coronavirus disease 2019 (COVID-19).

JULIE JONES, complimented a member of the public for assisting in finding her missing daughter.

ELSA J. SANCHEZ, 6930 NW 15TH STREET, thanked the City for the International Day Festival which she enjoyed and was looking forward to next year's event. She thanked Office Specialist III, Edwards, for writing the minutes for the City Commission meetings, in particular, for March 20th.

DONNA L. FELLOWS, 6108 NW 9TH COURT, thanked City Commissioner Arserio for attending the bowling event and highlighted a forthcoming Pepsi sponsored tournament.

TRACY VAN WINKLE, 1020 SW 61ST AVENUE, congratulated former Chief of Police (CoP), Galaska on his retirement and said that he did a good job in Margate. She referenced taking care of City employees and suggested speaking to former staff members who had left.

JEFF DEVITO, PALM SPRINGS II CONDO ASSOCIATION, complained that his Homeowners Association's (HOA) fees in his community would almost triple by next year and referenced partial and full reserves and indicated that the Surfside condominium collapse at Champlain Towers South could have played a part in its increase.

COMMISSIONER ANTHONY N. CAGGIANO referred to the increases and alleged that Florida State Governor DeSantis did not agree with Mr. Devito and he continued to discuss the same.

Discussion ensued.

COMMISSIONER ANTONIO V. ARSERIO said that he felt everybody's pain and discussed the HoA and high insurance fees.

RICH ALIANIELLO, 7631 NW 23RD STREET, informed that he had to search for a new insurance company as he was dropped by his previous insurer.

VICE MAYOR SCHWARTZ discussed current rates and high insurance policies.

3) COMMISSION COMMENTS

COMMISSIONER CAGGIANO discussed the success of the International Day Festival.

COMMISSIONER JOANNE SIMONE highlighted this weekend's Household Hazardous Waste (HHW) event . She recognized the City's employees who go above and beyond to address residents' concerns and thanked the Department Heads and designees for their efforts.

COMMISSIONER ARSERIO thanked the residents who attended the Snuggle Buddy event and he discussed the same. He also thanked the City staff for the second annual International Day Festival. He repeated his wish to see a grant specific for HoAs which would improve on curb appeal, fencing around properties and entry way signage.

VICE MAYOR SCHWARTZ wished the Jewish community a Happy Passover.

MAYOR RUZZANO said Happy Passover. He questioned if the Paradise Garden's sign belonged to the City and said that it would be a great community project for the City and the residents to do.

CITY MANAGER CALE CURTIS indicated that he would review the ownership of the signage and agreed that it needed to be refreshed.

Discussion ensued.

MAYOR RUZZANO informed that there was a new Broward County Public Schools Superintendent, Dr. Howard Hepburn and wished him all the best. He missed the International Day Festival as he attended his daughter's participation in competing in the national championship cheerleading competition where he continued to discuss the same.

4) CITY MANAGER'S REPORT

CITY MANAGER CURTIS thanked Communications and Marketing Manager, Fallon, for organizing the International Day Festival and also Parks and Recreation, for their assistance in setting up the same. He said that he would continue to expand upon that event and make it bigger and better every year. He explained that at the last City Commission Workshop, the City Commission gave instructions to invite two of the CoP candidate recruiters, Florida Police Chief Association's (FPCA) and Colin Baenziger & Associates (CB&A) for some in-person interviews. He informed that the FCPA had declined to attend in person and would conduct a Zoom interview or alternative and that they did not offer a warranty on their services. He sought feedback from the City Commission whether to offer a virtual meeting with both of those recruiters or did they want him to seek an agreement with CB&A.

COMMISSIONER CAGGIANO confirmed that he was content with CB&A as they offered a warranty.

COMMISSIONER SIMONE was okay with CB&A.

COMMISSIONER ARSERIO explained that whilst he was okay with CB&A, initially, he was leaning towards the FCPA at the last City Commission Workshop but indicated that they probably could not provide the level of service that the City required.

VICE MAYOR SCHWARTZ indicated that initially, she would have preferred to speak to the recruiters in person prior to entering into an agreement.

MAYOR RUZZANO said that he had no problem with CB&A and introduced the Police Department's new Acting Major, Al Banatte, to the City Commission meeting.
