IN THE AMOUNT OF \$74,749

This is a Second Amendment to Interlocal Agreement ("Second Amendment"), made and entered into by and between BROWARD COUNTY, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY,"

and

CITY OF MARGATE, a municipal corporation of the State of Florida, hereinafter referred to as "CITY," collectively referred to as the "Parties."

RECITALS

WHEREAS, the Parties entered into an Agreement ("Agreement") dated December 17, 2013, for the administration by COUNTY of HOME Investment Partnerships funding ("HOME Funds") from the U.S. Department of Housing and Urban Development ("HUD"), allocated to CITY for minor home repair/weatherization activities; and

WHEREAS, the Parties entered into a First Amendment to extend the term of the Agreement on September 30, 2015, in order for CITY to complete the Project; and

WHEREAS, Exhibit "C-1," Timetable/Schedule for Project, is amended as provided herein; and

WHEREAS, the Parties have determined that this Second Amendment is reasonable and necessary and is in the best interest of the public; NOW, THEREFORE,

IN CONSIDERATION of the mutual terms, conditions, promises, and covenants hereinafter set forth herein, the Parties agree as follows:

1. The above recitals are true and correct and are incorporated herein as if set forth in full hereunder.
2. Article 6, Timetable, is amended as follows:

The term of this Agreement shall commence upon complete execution by the Parties, and shall end September 30, ~~2016~~ 2017, as further described in Exhibit "~~C-1~~ C-2," Timetable/Schedule for Project, unless extended or terminated earlier as provided for herein. This Agreement may be extended by the Parties for additional term(s) of up to one (1) year each, upon CITY's written request to the Contract Administrator, in order to complete the Project. For COUNTY, the County Administrator is authorized to enter into any extensions to the term of this Agreement. CITY shall expend the HOME Funds allocated to the Project within the term of this Agreement.

3. Exhibit "C-1," Timetable/Schedule for Project, is amended as provided in Exhibit "C-2," Timetable/Schedule for Project, attached hereto and incorporated herein.
4. This Second Amendment shall be effective upon full execution by the Parties.
5. Except as provided for in this Second Amendment, the terms of the Agreement, not inconsistent herewith, shall remain in effect.
6. This Second Amendment may be fully executed in multiple copies by the Parties, each of which, bearing original signatures, shall have the force and effect of an original document.
