2) PUBLIC DISCUSSION

ELSA J. SANCHEZ, 6930 NW 15TH STREET, provided feedback on Broward County's Planning Council meeting and referenced the golf course and affordable housing.

JONATHAN A. KRALJIC, 7357 FLORES WAY, read a statement which included comments on the enforcement of water restrictions in April and parking on sidewalks.

JULI VAN DER MEULEN, 2913 NW 68 LN., explained that she had the privilege of joining Station 58 to do a ride-along which she described as an eye-opening experience. She said that first responders needed to ensure that they were getting the staff and resources to do their jobs safely and effectively. She asked for consideration for parking for the seniors at the Sounds at Sundown.

3) COMMISSION COMMENTS

COMMISSIONER ANTHONY N. CAGGIANO discussed the Autism and Acceptance Day, the Tree Giveaway and the Prescription Drug Take Back events and thanked the Police Department and Parks and Recreation for their assistance.

COMMISSIONER JOANNE SIMONE asked to keep Police Department's Office Specialist III, Jedrey, in their thoughts and prayers for the loss of a family member. She thanked Parks and Recreation Director, Jones and his team for their rapid response in addressing park goers' concerns pertaining to the Dog Park. She said that the Tree Giveaway last Saturday was awesome and the Prescription Drug Take Back was another great event. She thanked the Police Department for addressing cars parked across the sidewalks and forewarned that drivers could be given a citation.

VICE MAYOR ARLENE R. SCHWARTZ referenced Mr. Kraljic and said that she hoped the Police Department would get to their neighborhoods pertaining to parking across the sidewalk. She reaffirmed everything of what had been discussed on the Tree Giveaway, the Medication Take Back and the Autism and Acceptance Day. She wished everybody a Happy Mother's Day for May 12th.

MAYOR TOMMY RUZZANO wished everybody a Happy Mother's Day. He highlighted today's grand opening at Nakama Sushi Thai. He discussed Charley Katz. He said that Parks and Recreation was installing the lights at Andrews Field (AF). He requested that City Manager Curtis write a letter to Broward County School Board (BCSB) to inform them of all the work that the City had completed at AF and suggested that they could partner up and do some sort of matching grant. He advised that the BCSB was closing three schools.

COMMISSIONER CAGGIANO explained that he spoke against the potential closures to BCSB as he believed that it was a destruction of the school system.

MAYOR RUZZANO discussed developers coming to the City, attainable housing and green space. He was sad that they were losing the golf course and discussed another golf course where he had received comments about retaining it as it was. He heard that Margate Middle School was in consideration for closure.

Discussion ensued.

CITY ATTORNEY DAVID N. TOLCES provided an update on the Form 6 litigation and said that there was a hearing before the Judge on the request for the injunction. He said that they were hoping to receive an Order in the next couple of weeks and advised that in the meantime, they should hold off doing anything until they have received the Judge's ruling. He congratulated his son, Ryan, who was graduating tomorrow from University of Central Florida (UCF).

Discussion ensued.

VICE MAYOR SCHWARTZ explained that prior to the City Commission meeting, she met Federation of Public Employees' Representative, Jack Marziliano, outside who asked that once this Item had been voted upon, to thank the City Commission, on behalf of his union for passing this.

MAYOR RUZZANO said that he also met with Mr. Marziliano, who said that it was a tough negotiation but it went smooth.

Discussion ensued.

A motion was made by Commissioner Caggiano, seconded by Vice Mayor Schwartz, that this Resolution, should be discussed.

VICE MAYOR SCHWARTZ questioned whether the City was still allowed to educate the public when there was a Referendum going on the ballot.

CITY ATTORNEY TOLCES said that it had changed and that the City was restricted in not being able to use any funds with respect to advocacy or educating. They could not distribute material but they could include items that reference facts pertaining to the Resolution on the City's website or if the City was distributing the quarterly newsletters where they could include factual information in there, as long as they were not expanding any additional funds to educate, promote or advocate for that. He advised that there was

supporting back-up documentation from Estrada Hinojosa and representatives were available from that organization if the City Commission had any questions. He said that the information from the PowerPoint presentation which would be included as part of the Agenda materials could be referenced in anything they upload on the City's website or newsletter.

Discussion ensued.

MAYOR RUZZANO described himself as proactive who looked towards the future and highlighted his two concerns on a Reverse Osmosis (RO) waterplant. He believed that if they were going to spend a significant amount of money to install an RO, he thought that it would have been appropriate to have that included in this Resolution and complete it at the same time rather than having to return for another bond.

VICE MAYOR SCHWARTZ said upon taking a tour of the wastewater plant. She indicated that it was long overdue and referenced receiving complaints about odors.

COMMISSIONER CAGGIANO explained why it was vital to have this implemented.

COMMISSIONER ARSERIO explained that this bond was technically paid for by user fees. They raised the water rates by 25% and that it was to enable to obtain this bond which would prevent an additional increase on the tax bill.

RICHARD ZUCCHINI, 380 LAKEWOOD CIRCLE E, #B, requested to hear the presentation by staff before submitting public comments.

Discussion ensued on whether the presentation on this Item should take place.

THE CITY'S MUNICIPALITY ADVISER, LOURDES REYES ABADIN, explained that she had been working with staff on a presentation that included a lot of information on the water and wastewater project. She advised that the back-up for this Agenda Item was not to give a presentation just to include everything. She also informed that it would be a repository for where they could extract data to educate the public at a later time.

Discussion ensued.

VICE MAYOR SCHWARTZ read an extract from the organization's first page.

MS. SANCHEZ sought clarity on how the public could obtain information on how the system works.

CITY ATTORNEY TOLCES explained that they needed to work with City staff and the City Commission to make sure that they comply with the limitations placed on the City under Florida Law with respect to not being able to spend money to advocate, send out flyers or produce materials. He advised that the City would be able to present the information in a way that complies with State law.

Discussion ensued on the process.

MAYOR RUZZANO questioned whether the City Commission could advocate for this.

CITY ATTORNEY TOLCES advised that it was a fine line between what the City could do versus what the City Commission could do as politicians in their amendment rights to speak on behalf of issues.

Discussion ensued.

The motion carried by the following vote:

7) DISCUSSION AND POSSIBLE ACTION

A. <u>ID 2024-153</u> CALYPSO COVE WATER PARK PASSES FOR ELEMENTARY AND MIDDLE SCHOOL GRADUATES AND MARGATE SPORTS TEAMS

MAYOR RUZZANO explained that he placed this Item on the Agenda as they were going to open up their park again, similar to a grand reopening and referenced that in past practices, they gave passes to the children that were graduating and those who joined their sports league. He indicated that the park would be showcased as the children would be accompanied with others.

CITY MANAGER CURTIS advised that if they considered all the public and charter schools, he estimated approximately 4,000 passes He said that it would be \$6 for a adult pass and that they would allow teachers and veterans to get in.

Discussion ensued.

COMMISSIONER ARSERIO indicated that the parents could buy adult beverages and concessions.

COMMISSIONER CAGGIANO looked at this as a loss leader but said it would be an opportunity to get people in.

COMMISSIONER SIMONE questioned if there was an age restriction.

CITY MANAGER CURTIS confirmed that the minimum age restriction was 12 years old without a parent.

Discussion ensued on evaluating the age limit.

MAYOR RUZZANO questioned if the pass could say that the child had to be accompanied by an adult.

CITY MANAGER CURTIS indicated that they would come up with the appropriate language.

COMMISSIONER CAGGIANO questioned if the pass could have a special ID to know that it was working.

COMMISSIONER SIMONE requested that an expiration date to the passes should also be applied.

CITY MANAGER CURTIS confirmed that the passes were good for 12 months from the date they were issued.

CITY ATTORNEY TOLCES provided advice on the motion.

COMMISSIONER CAGGIANO wanted this Item to be brought back at a future Agenda to reevaluate the age.

A motion was made by Commission Caggiano, seconded by Vice Mayor Schwartz, to authorize the City Manager to provide passes for the graduating students with the restriction that the individual be accompanied by a paying adult.

MR. KRALJIC explained his opposition to this initiative suggesting that they should consider the financial impact it would have on the City.

MAYOR RUZZANO informed that the City increased the number of lifeguards at that facility quite recently.

Discussion ensued on Mr. Kraljic's comments.

The motion carried by the following vote:

[Appendix A – Zoning – Section 3.3] Any representation made before any City Board, any Administrative Board, or the City Commission in the application for a variance, special exception, conditional use or request for any other permit shall be deemed a condition of the granting of the permit. Should any representation be false or should said representation not be continued as represented, same shall be deemed a violation of the permit and a violation of this section.
