L. Exceptions		
1. All City of Margate employees shall be charged at the resident rate.		
2. Existing City of Margate sponsored leagues are exempt from mobile stage fees, and facility use fees for recreational practices and games use.		
3. Waiving of any fee shall be approved by a motion of the City Commission. Must meet fee waiver eligibility requirements.		
4. Any facility/open space not specified above, shall be charged based on the most applicable fees set forth by the Parks and Recreation Director.		
5. Fees for City operated programs and special events shall be adjusted by a written recommendation from the Parks and Recreation Director, and approved by the City Manager or designee, in order to maintain proper cost recovery.		

M. Refunds, or Credits

1. Refunds/Credits up to \$500, requires approval of the Parks and Recreation Director, or Designee.
2. Refunds/Credits greater than \$500, requires approval of the City Manager.
3. Refunds/Credits greater than \$1,000, requires approval by a motion of the City Commission.

N. Policies, rules, and regulations

1. Proof of general liability insurance naming the City of Margate as additionally insured or equivalent proof of insurance for other governmental agencies.
2. Use of the mobile stage shall be limited to the boundaries of Broward County.
3. All other rules and regulations for use of the facilities and properties shall be set by the Parks and Recreation Director with approval of the City Manager as provided for by City Code.
