A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING THE WAIVING OF BIDDING FOR SOLE SOURCE ACQUISITION OF TRIMBLE X9 FORENSIC LASER SCANNING SYSTEM, FROM THE FEDERAL LAW ENFORCEMENT TRUST FUND ACCOUNT, TO CAPTURE AND DOCUMENT EVIDENCE ON MAJOR VEHICLE CRASH SCENES, AT A COST NOT TO EXCEED \$75,000.00; PROVIDING FOR EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate, Florida approves waiving of bidding for sole source purchase of a Trimble X9 Forensic Laser Scanning System to capture and document evidence on major vehicle crash scenes, utilizing funds from the Federal Law Enforcement Trust Fund, in an amount not to exceed \$75,000.00.

SECTION 2: That the expenditure is deemed to be in the best interest of the City of Margate.

SECTION 3: The Chief of Police recommends the expenditure in Federal Law Enforcement Trust Funds ("LETFs") to capture and document evidence on major vehicle crash scenes, by purchase of a Trimble X9 Forensic Laser Scanning System.

SECTION 4: The Chief of Police certifies the expenditure in LETFs for a Trimble X9 Forensic Laser Scanning System for the Police Department, in that the funds will be used for an appropriate law enforcement purpose.

SECTION 5: The Chief of Police certifies the expenditure in LETFs for a Trimble X9 Forensic Laser Scanning System, in that the funds are not being used as a normal source of revenue for the Police Department.

SECTION 6: The Chief of Police certifies the expenditure in LETFs for a Trimble X9 Forensic Laser Scanning System for the Police Department in that the funds were not considered in the adoption and approval of the Police Department

budget.

SECTION 7: That the Mayor and City Manager are authorized and directed to execute the Agreement for the above acquisition, and the administration is authorized to issue a purchase order and execute all associated documents in order to implement same.

SECTION 8: That this Resolution shall become effective immediately upon its passage.
