**SUBJECT: Florida Contraband Forfeiture Act - Donation**

In accordance with the Florida Contraband Act, the Margate Police Department is required to expend or donate no less than twenty five percent of the fiscal year's total collection of state forfeiture funds. To meet this requirement, approximately \$7,000.00 must be donated to charitable organizations within the guidelines of Florida State Statute 932.7055.

We are requesting \$1,500.00 be donated to Florida Missing Children's Day Foundation, which is a non-profit organization and is a permissible entity to receive the donated funds. This organization handles projects for various missing persons' safety and prevention programs.

Florida Missing Children's Day Foundation creates billboards and ceremonies to raise awareness of missing children in Florida. They work toward educating the public on child safety and abduction prevention.

Attached is the W-9 form and back up information regarding Florida Missing Children's Day Foundation.

### Purpose of Form
