Proposal for Bid # 2024-002:

As per our site visit held on 1/16/2024, Sammet Pools, Inc. proposes the following:

- Remove and haul away existing play structure inside the Activity pool.
- Demo areas of pool floor as needed to install new footers as per plans.
- Relocate existing plumbing as needed for new footprint of new play structure. (New play structure supplied and installed by others).
- After installation of new play structure by others, we will undercut existing tile and floor returns. Chip and remove loose existing pool surface, acid wash and bond cote entire pool.
- Resurface Activity Pool with choice of standard light color, HRS approved Diamond Brite or equal finish.
- Carbon filter city fill water, fire up pool, balance chemicals and 30-day pool service included.
- Deck repairs for Plunge pool. Saw cut, remove and haul away a 8" X 17" existing section of concrete deck on the northside of the Plunge Pool close to the slides. The adjacent trees have pushed up the concrete deck making it a tripping hazard and also a violation for Health Department. We will cut away and remove the roots that are causing this problem and haul away. We will form, steel and pour new concrete in same footprint. The new concrete deck repair will be topped with spray deck type topping and colored to match the existing deck as best as possible. Southside of Plunge pool there is approximately 104 SF

of decking that needs to be raised a little bit. We will float the low area as needed, top with same spray deck type topping and color to match existing deck as best as possible. If deck repairs are not needed deduct (\$ 9,872.00) from our proposal.

Total Amount of Proposal \$ 165,000.00

Optional:

To expand the pool deck, we will excavate, remove grass, form, steel/wire mesh, pour concrete, top with spray deck topping with (2) coats of color sealer and (1) coat of clear sealer to match existing deck color as best as possible. our SF price is \$ 23.50 per SF
