RESOLUTION OF THECITY OF FLORIDA, APPROVING THE WAIVER OF BIDDING REOUIREMENTS FOR THE ACOUISITION FROM THE FEDERAL LAW ENFORCEMENT TRUST FUND ACCOUNT TO ENHANCE THE POLICE DEPARTMENT'S K-9 UNIT ΤO INCLUDE THE PURCHASE OF ONE REPLACEMENT CANINE, MISCELLANEOUS K-9 AND HANDLER EQUIPMENT, AND TRAINING, AT A COST EXCEED \$23,050.00; PROVIDING EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate, Florida approves the waiver of bidding requirements to enhance the Police Department's K-9 unit to include the purchase of one (1) replacement canine, miscellaneous K-9 and handler equipment, and training utilizing funds from the Federal Law Enforcement Trust Fund, in an amount not to exceed \$23,050.00.

SECTION 2: That the expenditure is deemed to be in the best interest of the City of Margate.

SECTION 3: The Chief of Police recommends the expenditure in Federal Law Enforcement Trust Funds ("LETFs") to enhance the Police Department's K-9 unit to include the purchase of one (1) replacement canine, miscellaneous K-9 and handler equipment, and training.

SECTION 4: The Chief of Police certifies the expenditure in LETFs for one (1) replacement canine, miscellaneous K-9 and handler equipment, and training for the Police Department, in that the funds will be used for an appropriate law enforcement purpose.

SECTION 5: The Chief of Police certifies the expenditure in LETFs for one (1) replacement canine, miscellaneous K-9 and handler equipment, and training for the Police Department, in that the funds are not being used as a normal source of revenue for the Police Department.
