A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING THE MARGATE PUBLIC TRANSPORTATION AGENCY SAFETY PLAN ("PTASP"); PROVIDING FOR THE ADMINISTRATION TO SUBMIT THE PTASP TO BROWARD COUNTY ON AN ANNUAL BASIS WITHOUT FURTHER CITY COMMISSION ACTION; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Broward County, through the Transportation Department, Transit Division ("BCT"), operates, financially supports, and oversees safe, friendly, and well-utilized public transportation within the urbanized area, which includes fixed route, Paratransit, Community Shuttle, and express bus services; and,

WHEREAS, Broward County is a recipient of significant annual funding from the U.S. Department of Transportation, Federal Transit Administration ("FTA"); and,

WHEREAS, pursuant to 49 C.F.R. Part 673, the FTA requires public transportation operators that receive federal funding to have an approved Public Transportation Agency Safety Plan ("PTASP") to continue to be eligible for FTA funding, and

WHEREAS, although the City does not receive direct federal funding from the FTA, Broward County has requested the City Commission approve the City's current PTASP and submit it to Broward County; and

WHEREAS, Broward County requests that subsequent to the City Commission approval of the current PTASP, that City Administration annually submit the City's PTASP to Broward County, to provide for County compliance with 49 C.F.R. Part 673.

NOW, THEREFORE, BE IT RESOLVED FOR THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the foregoing WHEREAS clauses are hereby ratified and confirmed to be true and the same are hereby made a part of this Resolution.

SECTION 2: The City Commission of the City of Margate approves the City of Margate Public Transportation Agency Safety Plan ("PTASP").

SECTION 3: The City Commission of the City of Margate authorizes the Administration to provide for the annual submission of the City's PTASP to Broward County without further City Commission action.

SECTION 4: This Resolution shall become effective this date.
