A RESOLUTION OF THE CITY OF MARGATE, FLORIDA SUPPORTING THE DESIGNATION OF THE BRIDGE ON STATE ROAD 7 OVER SAMPLE ROAD AS "SPC DANIEL J. AGAMI BRIDGE", AS APPROVED IN FLORIDA HOUSE BILL 987 APPROVED BY THE GOVERNOR ON JUNE 13, 2025, AND ENROLLED AS PART OF CHAPTER NO. 2025-214 ON JULY 8, 2025; PROVIDING FOR STREET SIGNS OR MARKERS TO BE PLACED BY THE DEPARTMENT OF TRANSPORTATION; PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** Army Specialist Daniel J. Agami of Coconut Creek, Florida, was killed in action on June 21, 2007, at the age of 25 from injuries sustained when an improvised explosive device detonated near his vehicle in Adhamiyah, Iraq; and

**WHEREAS,** SPC Agami, known affectionately as "The Hebrew Hammer," enlisted in the U.S. Army in 2005 and completed his basic training at Fort Benning, Georgia; and

**WHEREAS,** SPC Agami was assigned to the 1st Battalion, 26th Infantry Regiment, 2nd Brigade Combat Team, 1st Infantry Division, based in Schweinfurt, Germany and was deployed to Iraq in 2006; and

**WHEREAS,** SPC Agami was a highly decorated soldier and received numerous honors for his service, including the Bronze Star Medal, Purple Heart, Army Commendation Medal, Army Good Conduct Medal, Global War on Terrorism Service Medal, Iraq Campaign Medal, and Combat Infantryman's Badge; and

**WHEREAS, SPC Agami** began his education at the Hebrew Academy Community School in Margate, Florida, where he built the foundation of his strong Jewish identity and deep sense of service; and

**WHEREAS,** Florida House Bill 987 approved by the Governor on June 13, 2025, and enrolled as part of Chapter 2025-214 on July 8, 2025, provided for the designation of the bridge on State Road 7 over Sample Road in Broward County to be designated as "SPC Daniel J. Agami Bridge; and

**WHEREAS,** portions of the aforementioned bridge is situated in the cities of Margate, Coconut Creek, and Coral Springs; and

**WHEREAS,** the City Commission of the City of Margate wishes to join his Gold Star Parents Itzhak and Beth Agami, his brother Ilan, and his sister Shaina, in remembering and honoring SPC Daniel J. Agami.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:**

**Section 1:** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

**Section 2:** That the City Commission hereby expresses its heartfelt support of the State Road 7/Sample Road bridge designation in honor of SPC Daniel J. Agami and authorizes the Department of Transportation to place suitable signs or markers within the City of Margate to provide for the bridge designation as provided in Chapter 2025-214, Laws of Florida.

**Section 3:** That the City Clerk is hereby directed to furnish a copy of this Resolution to the Office of Senator Tina Polsky.

**SECTION 4:** This Resolution shall become effective immediately upon its passage.
