A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING THE WAIVER OF BIDDING REQUIREMENTS FOR THE PURCHASE OF ONE HUNDRED FIFTEEN (115) NEW GLOCK 9MM PISTOLS 45MOS AND (135) HOLOSUN 509T X2 SIGHTS WITH ANCILLARY EQUIPMENT FOR THE POLICE DEPARTMENT, FROM LOU'S POLICE DISTRIBUTOR'S, INC.; PROVIDING FOR SURPLUS; PROVIDING FOR TRADE-IN CREDIT TOWARD THE PURCHASE PRICE; PROVIDING FOR FUNDING FROM THE STATE LAW ENFORCEMENT TRUST FUND IN AN AMOUNT NOT TO EXCEED \$98,000; PROVIDING FOR EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate, Florida, approves the waiver of bidding requirements for the purchase of one hundred fifteen (115) new Glock 9mm pistols 45MOS and (135) Holosun 509T X2 sights with ancillary equipment, for the Police Department, from Lou's Police Distributor's, Inc., and declares the current Glock pistols and sights as surplus to the needs of the City and to be utilized as a trade-in toward the purchase of the new Glock pistols, utilizing funds from the State Law Enforcement Trust Fund in a total amount not to exceed \$98,000.

SECTION 2: That the expenditure is deemed to be in the best interest of the City of Margate.

SECTION 3: The Chief of Police recommends the expenditure in State Law Enforcement Trust Funds ("LETFS") for the purchase of one hundred fifteen (115) Glock 9mm pistols 45MOS and (135) Holosun 509T X2 sights with ancillary equipment for the Police Department.

SECTION 4: The Chief of Police certifies that the expenditure in State LETFS for the purchase of one hundred fifteen (115) Glock 9mm pistols 45MOS and (135) Holosun 509T X2 sights with ancillary equipment for the Police Department in that the funds will be used for an appropriate law enforcement purpose.

SECTION 5: The Chief of Police certifies that the expenditure in State LETFS to for one hundred fifteen (115) Glock 9mm pistols 45MOS and (135) Holosun 509T X2 sights with ancillary

equipment for the Police Department, in that the funds are not being used as a normal source of revenue for the Police Department.

SECTION 6: The Chief of Police certifies that the expenditure in State LETFs for the one hundred fifteen (115) Glock 9mm pistols 45 MOS and (135) Holosun 509T X2 sights with ancillary equipment for the Police Department in that the funds were not considered in the adoption and approval of the Police Department budget.

SECTION 7: That the Mayor and City Manager are authorized and directed to execute contracts for the above acquisition, and the administration is authorized to issue a purchase order and execute all associated documents in order to implement same.

SECTION 8: That this Resolution shall become effective immediately upon its passage.
