Voluntary Price Reduction

Since the previous contract was awarded in August 2013, the Consumer Price Index (CPI) for All Urban Consumers has increased 12%.

Prices were compared to the current contract, which was awarded in August 2013, on 46 out of 52 items. Prior to the voluntary price reduction, bid pricing was 33.7% higher than the current prices on 46 comparable items. The vendor offered an overall voluntary price reduction \$79,485.90, which lowers the percentage difference to 23.4%.

In an email dated August 30, 2018, Clean Harbors Environmental Services, Inc. indicated the price increases from 2013 were a result of an average CPI increase of 3-4% each year, along with maintaining fixed pricing for possibly another three years. The vendor also indicated that increased operating costs, fuel, labor and insurance as being the most notable driving factors for the increase.
