Thank you for contacting us with your court needs. Fast-Dry Courts, Inc. offers to resurface two (2) tennis courts and three (3) half basketball courts at Coral Gate Park in accordance with the City of Cooper City Co-Op Bid #2018-5-PW awarded pricing. We will use Tropicoat® Color and Laykold acrylic resurfacer on all courts. All work carries a 1 year workmanship guarantee. If park does not have power or water on site, we will provide our own power generator but city must provide potable water. We will make every effort to secure our materials but any vandalism done to the court surfaces while working will be repaired and billed accordingly.

\$15,280.50 - Resurface two (2) asphalt tennis courts, in one battery, measuring 117' x 122'. Pressure clean to remove mildew and flood entire surface; patch low areas greater than +/- 1/8" and cracks wider than +/- 1/16"; apply 4 coat acrylic color system, including 2 coats of Laykold acrylic resurfacer, 2 coats of Tropicoat® acrylic court paint and playing lines to USTA specifications; repaint net posts (green); furnish and install two (2) new Six Star II tennis nets with center straps, and anchor mates with locking bands.

\$10,523.50 - Additionally, resurface three (3) asphalt half-basketball courts, in one battery, measuring 50' x 150', including the viewing area outside of the north fence line. Pressure clean to remove mildew and flood entire surface; patch low areas greater than +/- 1/8" and cracks wider than +/- 1/16"; apply 4 coat acrylic color system, including 2 coats of Laykold acrylic resurfacer, 2 coats of Tropicoat® acrylic court paint and high school regulation basketball playing lines.

Outside of the Co-Op but recommended for better results, FDC will remove 150 linear feet of 10' tall chain link mesh with mid and bottom rail along the north fence line to allow access to the entire court area; rehang chain link mesh and mid and bottom rail for the additional cost of \$1,500.00. NOTE: The fence materials will be stored on site during the resurfacing.
