SUBJECT: Policy – Request to waive fees

---

This policy serves to standardize and streamline the procedure in which organizations, and/or residents request the waiving of fees associated with the rental/use of the City of Margate facilities and open spaces in accordance with Resolution No. 21-029.

- Any group/person applying for waiving of fees must fall under one of the following designations:
  - Margate based certified 501(c)(3) organization
  - Margate based non-profit organization
  - Margate based civic group
  - Margate home owners association
  - Margate school (Public, or Private)
  - Margate place of worship
  - Margate resident with a justified financial hardship
- For-profit organizations are **NOT** eligible for waiving of permit fees, and must negotiate a sponsorship agreement approved by the City Manager.
- Requests to waive fees are limited to two (2) facility use permits per year.
- The group/person must attend or have a representative attend the Regular Commission Meeting at which their Request to Waive fees is on the agenda.
- Security Deposit fees are not eligible to be waived.
