

ORDINANCE NO. 2016-005

AN ORDINANCE OF THE TOWN OF DAVIE, FLORIDA, AMENDING CHAPTER 16, ARTICLE I, SECTION 7, CODE OF ORDINANCES TITLED, "SMOKING AND VAPING PROHIBITED IN OUTDOOR AREAS IN TOWN PARKS", PROVIDING FOR CONFLICT, PROVIDING FOR SEVERABILITY, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Article VIII, Section 2 of the Florida Constitution and Chapter 166 of the Florida Statutes, the Town of Davie is authorized to protect the public health, safety, and welfare of its residents and has the power and authority to enact regulations for valid governmental purposes that are not inconsistent with general or special law; and

WHEREAS, the Town Council finds it periodically necessary to amend the Town's Ordinances in order to remain up to date with the advent of new technology; and

WHEREAS, the Office of the Town Attorney desires to amend Chapter 16, Article I, Section 7 of the Town of Davie Code of Ordinances; and

WHEREAS, the proposed ordinance amendment is within the police power of the Town of Davie; and

WHEREAS, the existing language needs to be amended and fails to specifically include electronic vaporizers; and

WHEREAS, The Town Council finds that this Ordinance is necessary for the preservation of the public health, safety, and welfare of the Town's residents; and

WHEREAS, The Town Council deems it to be in the best interest of the citizens and residents of the Town of Davie to adopt the proposed amendments; and

WHEREAS, the Town Council has legally advertised its intent to update Chapter 16, Article I, Section 7 of the Town of Davie Code of Ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Ordinance.

SECTION 2. The amended Chapter 16, Article I, Section 7, is hereby adopted as set forth in Exhibit "A".

SECTION 3. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portion of this ordinance.

SECTION 4. All ordinances or parts of ordinances in conflict herewith are to the extent of such conflict hereby repealed.

SECTION 5. This Ordinance shall become effective immediately upon passage and adoption.

EXHIBIT "A"

Sec. 16-7. - Smoking and vaping prohibited in outdoor areas in town parks.

- (a) It shall be unlawful for any person to smoke cigarettes, cigars, pipes, use electronic vaporizers, or any other smoking apparatus or vaping device on playing fields and playgrounds, bleacher areas, dugouts, around team seating areas, concession areas, spectator areas, rodeo grounds, restrooms, or any other areas not specifically designated as a permitted smoking area within any park owned and operated by the Town of Davie. All designated smoking areas will be specifically demarcated by signs stating that "smoking is permitted in this area."
- (b) ~~Upon an individual's first violation of this section, a town official or law enforcement officer may issue a warning to any person in violation of the provisions of this section. Any refusal by an individual to comply with this section upon issuance of a warning may result in a notice to appear being issued by a law enforcement officer for the violation and/or removal from the park. Upon the first conviction of this violation, a court of competent jurisdiction may impose a fine of twenty-five dollars (\$25.00). Any person who violates this ordinance shall be subject to a civil fine of \$100.00, for the first violation and \$250.00 fine for subsequent violations. Any refusal by an individual to comply with this section may result in a notice to appear being issued by a law enforcement officer and/or removal from the park.~~
- (c) ~~Any subsequent conviction of a violation of this section may result in additional fines and penalties, including court costs imposed by a court of competent jurisdiction. Any appeals shall be filed with the special magistrate for the Town of Davie and be governed by the rules set forth in the special magistrate.~~
- (e d) This section shall not apply to any person smoking within inside a vehicle within a parking lot located in a town park or playing field. a parking lot located in a town park.

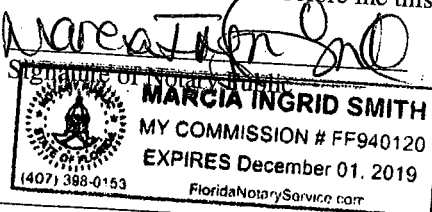
