CAROL SJURSEN spoke on this proclamation. She sent an open invitation to an event on the weekend of June 28th and 29th pertaining to a training exercise.

Discussion ensued.

## **2) PUBLIC DISCUSSION**

MAYOR, ARLENE R. SCHWARTZ, provided instructions on how to submit a Public Discussion.

FT. LAUDERDALE RESIDENT, GARY METZ, recognized that Margate had an outstanding Community Emergency Response Team (CERT) program and emphasized the importance that the City should become involved in an Amateur event next weekend.

MARGATE RESIDENT, TRACY VAN WINKLE, queried a previous reference about CERT and said that Margate had not had a team for a long time.

MARGATE RESIDENT, MR. KRALJIC, read a statement pertaining to the State being free of fluoride from July 1st, term limits and adding a flashing school zone sign to Atlantic Boulevard/66th Avenue.

Meeting went into Recess.

Meeting Reconvened.

## **3) COMMISSION COMMENTS**

COMMISSIONER, TOMMY RUZZANO, congratulated Office Specialist I Hayes and Parks & Recreation Director, Jones and said that they were both doing a great job for the City. He informed that Florida's budget was passed and welcomed the new recruits to the Fire Department. He gave a shout out to Winn-Dixie and referenced ice pops and Margate's 4th July parade. He said that the City received a letter from Broward County Public Schools (BCPS) which referenced the property which they owned next to Margate Elementary School where they asked if it could be rezoned to residential to do affordable housing for the teachers. He continued to discuss issues with the BCPS and their budget and was against rezoning the land.

COMMISSIONER, ANTHONY N. CAGGIANO, congratulated the new recruits at the Fire Department and said it was a beautiful service. He congratulated the Florida Panthers and hoped it was a great Father's Day. He said that Doc Reno's Wingsfest 2025 was well attended. He wished a Happy Pride Month to the Lesbian, Gay,

Bisexual, and Transgender (LGBT) community, a Happy Juneteenth and that he was looking forward to seeing people attend 4th July Extravaganza. He forewarned about hurricane preparedness.

COMMISSIONER, JOANNE SIMONE, congratulated the employees for their years of service. She spoke of a neighbor's dispute pertaining to overgrown trees which had caused damage to some parts of their property and she asked for a resolution from the City in cases such as these.

MAYOR SCHWARTZ, explained that the City Manager informed her that Building Code Services had visited those properties.

VICE MAYOR, ANTONIO V. ARSERIO, highlighted the 4th July Extravaganza and would add drones to the celebration but would not remove the firework display.

COMMISSIONER SIMONE was not in favor of fireworks.

MAYOR SCHWARTZ congratulated new members of the Fire Department who were off probation. She said that in reference to Margate Elementary School, Dave Thomas Education Center used to be Winn-Dixie. She also highlighted the past problems with BCPS and referenced funding and vouchers.

Discussion ensued on Margate schools, a housing component and teacher's salaries.

#### **4) CITY MANAGER'S REPORT**

CITY MANAGER, CALE CURTIS, provided an update on residential neighborhood parking on the grass and said that the Ordinance had been drafted and will be read at July's Planning and Zoning board meeting and thereafter, it will be brought to the City Commission for consideration.

COMMISSIONER RUZZANO, questioned if Homeowners Associations (HOA) could overrule that decision.

CITY ATTORNEY, DAVID N. TOLCES, explained that the HoA could be more restrictive which the City would not get involved with.

CITY MANAGER CURTIS explained that the State Legislator passed the budget earlier this week and thanked their lobbyist and State Representatives. He also gave kudos to Public Works Director Batista and the Department of Environmental and Engineering Services (DEES), Director Keyser's respective teams for putting together the grant packages and he was pleased to report that:

\$1,200,000 - Matching funds for the City;  
500,000 – Matching grant for storm water improvements; and  
700,000 – Matching grant for the water treatment plan.

CITY ATTORNEY TOLCES was pleased to report that as a result of his office filing a motion on behalf of the City to recover surplus proceeds, Margate was awarded approximately \$62,000 for some outstanding Code liens for a property on Vista Way. He wished everyone a Happy 4 July.

**A motion was made by Commissioner Caggiano, seconded by Vice Mayor Arserio, that this Resolution should be approved.**

COMMISSIONER RUZZANO advised that the Contractor of the Margate Fire Department Station 58 returned with changes to a previously agreed contract and referenced a price increase during the Coronavirus disease 2019 (COVID-19) pandemic. He said that we should fight it and go to court.

MAYOR SCHWARTZ indicated that the increase from the Contractor was because he did not buy the bathroom fixtures due to storage. She said that if the Contractor compromised, he may have seen more than what he was currently asking for. She did not know whether it was a bad idea to settle for that amount as it would cost more to go to court.

COMMISSIONER RUZZANO spoke further on this Item and referenced liquidated damages and believed that the Contractor owed the City money. He encouraged his peers not to vote for this.

VICE MAYOR ARSERIO'S understanding was that when the City reached a settlement number, they would deduct it for liquidated damages. He was torn on this Item.

CITY MANAGER CURTIS explained that the Contractor came to the City with an approximate amount of \$370,000 and that this settlement agreement was based on the concept of splitting that amount in half and deducting the liquidated damages from there. He forewarned of the costs which could incur if an out of settlement agreement was not agreed as that was the safest, cheapest way out. He also confirmed that there would be staff involvement if the City had to go to court.

Discussion ensued including language contained within contracts.

MS. VAN WINKLE questioned what the issue was with Margate and permits and also highlighted previous problems that the City had with contractors and developers.

## 8) DISCUSSION AND POSSIBLE ACTION

### A. [ID 2025-169](#) NONCONFORMING USES

CITY MANAGER CURTIS explained that at the last City Commission and Community Redevelopment Agency's (CRA) respective meetings, board member Ruzzano brought up some concerns about non-conforming uses and existing businesses that may be affected and asked that this be placed on the Agenda for discussion.

COMMISSIONER RUZZANO said that there was a proprietor in Margate that was deemed a non-confirming business. He said that the proprietor owned the Bell Plaza (GC Pawn) where the bay next to his Gold N Connection LLC was empty which he wanted to expand but unfortunately, it fell under the non-confirming rule. He wanted to see businesses succeed in his City and requested if the board review this and make it confirming.

VICE MAYOR ARSERIO was familiar with that establishment and in general, he was not the biggest fan of pawn shops but indicated that it appeared to be a pretty clean running organization. He wanted to peruse the non-conforming uses in Code and also review others that may need adjusting. He would caution totally removing that Code but would still apply some form of restriction that would give the City a final say and also on a case by case basis. He would be supportive of making adjustments but he did not want to lose complete control and he also did not want to invite an influx of pawn shops into the City.

COMMISSIONER CAGGIANO saw no reason to allow the pawn shop to expand.

MAYOR SCHWARTZ said that she received a letter yesterday informing her that the business owner had two small children and could not attend the meeting. She explained that the business proposed moving over into another bay and opening up the wall between the other and expanding it to double the size that it currently was. She forewarned "what you do for one, you do for all." She was doubtful if she would vote for it until she discussed it with the business owner. She questioned City Attorney Tolces what the situation would be to allow one business and to deny others.

Discussion ensued.

CITY ATTORNEY TOLCES explained that it would depend on the location and also in respect of various factors such as each individual business. He recommended working with the Community Development staff, reviewing the zoning district, see what uses were currently permitted and what had changed and then make an analysis and policy decision based upon those findings as opposed to just one location.

Discussion ensued including devising zones similar to the future downtown.

CITY MANAGER CURTIS sought instructions from the City Commission on this Item.

VICE MAYOR ARSERIO explained that he would like to see staff review the list and return with suggestions if they believed that adjustments needed to be made as well as the City Commission review the same.

Discussion ensued.

CITY ATTORNEY TOLCES believed that the best course of action would be to look at this from a broad policy decision and to identify the areas of interest. He advised that the City Commission could then decide, based upon the location, the zones and what they believed was in the best interest of the City, maybe what uses they wanted to allow as a special exception and which prohibited uses they wanted to retain. He indicated that there may be some other process to allow for a non-confirming use to come forward.

MAYOR SCHWARTZ concurred with City Attorney Tolces.

COMMISSIONER RUZZANO thought that City Attorney Tolces' suggestion could open up a bigger can of worms. He would specifically focus on the pawn shops, devise a policy and if they deem it non-confirming, they would have to come before the City Commission.

Discussion ensued including a car lot by the hospital.

MAYOR SCHWARTZ confirmed that the direction would be to receive a list of non-confirming uses which were in that corridor.

VICE MAYOR ARSERIO discussed the recent letter distribution of the fire assessment fee.

Discussion ensued.

## ADJOURNMENT

There being no further business, the meeting adjourned at 8:35pm.
