

THIS AMENDMENT is entered into between the Areawide Council on Aging of Broward County, Inc., hereinafter referred to as the “Council,” and **Northwest Focal Point Senior Center District**, hereinafter referred to as the “Contractor,” and collectively referred to as the “Parties,” to amend Contract JL116-08-2017.

The purpose of this amendment is to increase the contract amount by \$22,953.75 and increase the level of services accordingly, change the total contract funding from \$100,292.00 to \$123,245.75 and replace attachments.

(1) Section 4 is hereby amended to read as follows:

**4. Contract Amount:**

The Council agrees to pay for contracted services according to the terms and conditions of this contract in an amount not to exceed **\$123,245.75** or the rate schedule, subject to the availability of funds. Any costs or services paid for under any other contract or from any other source are not eligible for payment under this contract.

(2) Attachment II is hereby replaced with the revised Attachment II.

(3) Attachment IV is hereby replaced with the revised Attachment IV.

This amendment will be effective on the last date that this amendment has been signed by both Parties.

All provisions in the contract and any attachments thereto in conflict with this amendment shall be and are hereby changed to conform to this amendment.

All provisions not in conflict with this amendment are still in effect and are to be performed at the level specified in the contract.

This amendment and all of its attachments are hereby made a part of the JL116-08-2017 contract.
