Call to Order

The regular meeting of the Northwest Council of Elected Officials was called to order by Mayor Scott J. Brook on Monday, December 12, 2022 at 12:20 p.m. City Clerk Georgia Elliott served as recording secretary. The meeting was held at Country Club of Coral Springs, 10800 West Sample Road, Coral Springs, Florida.

Introductions

The floor was opened by Mayor Brook to allow for self-introductions of attendees.

Approval of Minutes November 14, 2022, meeting hosted by the City of Lauderdale Lakes

Commissioner Ken Cutler moved to approve the minutes of November 14, 2022, as presented. The motion was seconded by Vice Mayor Sandra Welch. The motion passed, unanimously.

Presentation

Deputy City Manager Catherine Givens presented on the City of Coral Springs' sustainability initiatives. A copy of her presentation, titled "What Sustainability Means to Coral Springs", was made part of this meeting packet. The following topics were covered in her presentation:

- A group survey on defining sustainability
- A review of Coral Springs' approach to achieving financial, operational, and environmental sustainability
- A review of Coral Springs' Sustainability Action Plan (SAP) and corresponding milestones

Ms. Givens extended an invitation to Council members to discuss sustainability partnership opportunities and best practices. City Manager Frank Babinec highlighted his agency's adoption of internal policies supporting sustainable purchases and practices. Members of the council shared their agencies efforts to support sustainability. The following topics were shared:

- Drafting of resolutions to ban single-use plastics
- Challenges with restocking vending machines with sustainable items
- Best practices on rolling out sustainability initiatives
- Best practices on communicating information to the public
- Adoption of a glass crusher pilot program

Old Business

Commissioner Bob Mayersohn shared that the Broward County Commission is scheduled to vote, on December 13, on the designation of a publicly accessible website for local government public notices pursuant to House Bill 7049. An outline of the process and potential challenges were discussed.

New Business

The council discussed effective methods to communicate to their constituents. Best practices were shared, including:

- Disseminating information through a designated agency cable channel
- Disseminating information through agency's website
- An array of social media platforms with each elected official having their own unique handle
- Publication of a quarterly informational resource
- Creation of YouTube public announcement videos, such as Coral Springs' recent "Mayor's Story – Suicide Awareness"

City Manager Babinec discussed the City of Coral Springs' Behavioral Health Access Program (BHAP). Mr. Babinec described BHAP as an employee-based resource, which pools all mental health and wellness resources into one area. Mr. Babinec reviewed the benefits of having an established BHAP program in his city and encouraged agencies interested in learning more about this program to contact him.

Mayor Brook shared a personal story of loss, due to suicide, and his creation of the Suicide Prevention Initiative. He urged fellow members to consider the BHAP program and to take a personal stance against the stigma associated with suicide.

Commissioner Mayersohn shared that a legislative update is forthcoming and stated that talking points are being developed on the potential change requiring certain municipal officials to file a Form 6.

An announcement was made by the hosting site informing attendees that sustainable straws were used for today's luncheon.

Mayor Brook announced that the next meeting will be hosted by the City of Margate. Attendees were thanked for their service and holiday wishes were exchanged.

Adjournment

There being no further business, the meeting was adjourned at 1:06 p.m.
