AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA AMENDING ORDINANCE 2021-9 AS AMENDED BY ORDINANCE 2022-2, PROVIDING FOR THE SECOND AMENDMENT TO THE EXCLUSIVE FRANCHISE AGREEMENT FOR SOLID WASTE AND RECYCLING COLLECTION SERVICES WITH REPUBLIC SERVICES OF FLORIDA LIMITED PARTNERSHIP D/B/A ALL SERVICE REFUSE TO PROVIDE CLARIFICATION REGARDING THE USE OF SCHOLARSHIP PROGRAM FUNDS; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate hereby approves the Second Amendment to the exclusive Franchise Agreement for Solid Waste and Recycling Collection Services within the City of Margate with Republic Services of Florida Limited Partnership d/b/a All Service Refuse, to provide for the use of the scholarship program funds for scholarships or other municipal purposes, a copy of which is attached hereto as Exhibit "A".

SECTION 2: All ordinances or parts of ordinances in conflict herewith are and the same is hereby repealed to the extent of such conflict.

SECTION 3: If any section, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction,

1 then said holding shall in no way affect the validity of
2 the remaining portions of this ordinance.

3 SECTION 4: It is the intention of the City Commission
4 that the provisions of this ordinance shall become and be
5 made a part of the City of Margate Code by reference.

6 SECTION 5: This ordinance shall become effective
7 immediately upon adoption at its second reading.
