The mission of the Margate Fire Department is to deliver the highest level of emergency medical services and fire protection to the community with professionalism and respect. We believe that your family is our family.




History





What is the NFPA

The National Fire Protection Association (NFPA) develops codes and standards for fire safety, electrical safety, and emergency responses, by providing guidelines, education, and advocacy to improve safety and prevent losses.

NFPA 1710

Standard for the Organization and Deployment of Fire Suppression Operations, Emergency Medical Operations, and Special Operations to the Public by Career Fire Departments


Defines the industry standard of fire truck staffing in order to accomplish all necessary tasks on a fire scene

Establishes the minimum number of firefighters needed to safely handle fires in houses, apartment buildings, strip malls, and large commercial buildings

These requirements are set to provide "effective, efficient, and safe protection to reduce the risk to lives and property"



NFPA 1710 has set forth these standards to guarantee a more coordinated and efficient approach to emergency operations:







OSHA® Occupational Safety and Health Administration 1910.134 OSHA Federal Regulation "2 in 2 out"

Firefighters engaged in interior structural firefighting work in the "buddy system"

(always be paired up)

If entering a toxic environment, at least two firefighters must go in together

For every two firefighters inside the structure, there should be two outside ready to assist

Those firefighters that are inside the toxic environment must maintain constant visual or verbal contact



Demonstrates that a well-staffed fire truck will significantly impact:

- The overall effectiveness of the Fire Departments
- Faster search & rescue
- Fire suppression
- Reduced property damage
- Lower casualty rates

Search times dropped by three minutes with a three-person crew





Figure 34: Times to Conduct Primary Search by Crew Size

Broward Countywide Standards and Mutual Aid

In 2002, residents voted for Closest Unit Response regardless of jurisdictional boundaries. Margate Fire Department began this operation in 2023.

For those calls that are life-threatening, it is the requirement for each fire truck to include a three-person crew or an augmented response (meaning manpower must be pulled from a different unit)


Often, we <u>must send the fire truck AND the rescue truck to fulfill our</u> <u>personnel requirements</u> to assist neighboring cities

This leaves the originating zone without available units, compromising the area's response readiness for any additional emergencies





Staffing Increase



Advancing toward National and Regional Standards

To meet agreed upon service levels of all fire rescue agencies of Broward County

Decrease response times

Enhance services to the community



Broward Countywide Standards and Mutual Aid

Moving to a three-person fire truck staffing model will increase the availability of in-zone units and will ensure:

Rapid and consistent emergency responses

Maintaining better unit coverage for additional incidents

Increased safety and effectiveness of mutual aid responses

Reinforced community standards and expectations



The High Demands of Firefighting

Firefighting involves significant mental and physical strain, carrying risk of injury

A three-person firefighting crew will <u>dramatically improve</u>:

Coordination of fire operations to better disperse the workload

The risk of injury from trauma, overexertion, overheating, and cardiac demand

The availability of "backup" in a dangerous environment such as rapid changes in fire conditions

Compliance with the "two in, two out" rule of firefighter survival



Meeting Regional Standard

Fire Truck Staffing

Broward County is home to close to 2 million residents, an estimated 14 million visitors, and has a total of 128 fire trucks.


125 of 128 fire trucks are equipped with a minimum three-person crew.





Enhancing Our Service





- Rapid initial fire attack
- Immediate Search & Rescue
- Establishment of water supply early
- Improves victim survivability
- Simultaneous tasking vs Sequential tasking
- Enables Command to maintain better control over the incident
- Enhances the safety measures taken to protect our residents and firefighters

Fastest Unit Response agreements throughout Broward County

Comparative analysis with local agencies

Moves toward the regional standard by staffing three firefighters on every fire truck
