

Chemical Safety Policy

Revision Year 2025

Purpose

The purpose of this policy is to protect employees and visitors of Landshore Enterprises from risks associated with the use, handling, storage, and disposal of hazardous chemicals. This policy complies with applicable federal, state, and local regulations, including OSHA's Hazard Communication Standard (29 CFR 1910.1200).

1. Scope

This policy applies to all Landshore Enterprises operations where chemicals or hazardous substances are present. It covers employees who may handle, use, store, or be otherwise exposed to chemicals in the workplace.

2. Policy Statement

Landshore Enterprises is committed to ensuring a safe work environment by implementing risk assessments, maintaining Safety Data Sheets (SDS), providing training, and enforcing safe practices for all chemical use, handling, and storage.

3. Risk Assessments

- **Pre-Use Assessments:** Before introducing any new chemical into the workplace, supervisors will evaluate the chemical's hazards, review its SDS, and determine appropriate controls.
- **Routine Assessments:** Supervisors will periodically assess chemical storage areas, labeling, PPE requirements, and employee practices to ensure continued compliance.
- **Job Hazard Analysis (JHA):** A JHA will be performed when chemical use is involved in specific tasks or processes, documenting risks and controls.

4. Safety Data Sheets (SDS)

- **Availability:** SDS for every hazardous chemical used, handled, or stored will be obtained, maintained, and made readily accessible to all employees at each work location.
- **Format:** SDS will follow the Globally Harmonized System (GHS) 16-section format.
- **Updating:** Outdated SDS will be replaced with current versions from the manufacturer or supplier.

5. Employee Training and Access to Information

- **Training:** All employees who handle, use, or may be exposed to hazardous chemicals will receive training at hire and annually thereafter. Training will include:

- Hazards of chemicals in the workplace
 - Proper handling, use, storage, and disposal procedures
 - Emergency response (spills, leaks, first aid)
 - Use and care of PPE
 - Understanding chemical labels and SDS
- **Access:** Employees have the right to review SDS, labeling information, and risk assessment results at any time.

6. Hazard Communication Program

Landshore Enterprises will maintain a written Hazard Communication Program that includes:

- **Chemical Inventory:** A current list of all hazardous chemicals present at each workplace.
- **Labeling System:** Use of manufacturer-provided labels and secondary workplace labels consistent with GHS requirements. Labels will include the product identifier, signal word, hazard statement(s), pictograms, precautionary statement(s), and supplier information.
- **Employee Notification:** Communication of chemical hazards through training, safety meetings, signage, and site postings.
- **Contractor Coordination:** Communication of chemical hazards with subcontractors, clients, or other contractors sharing the worksite.

7. Proper Storage and Labeling

- **Storage:**
 - Store chemicals in accordance with manufacturer instructions and SDS recommendations.
 - Segregate incompatible substances (e.g., acids and bases, flammables and oxidizers).
 - Maintain secondary containment for liquid chemicals where necessary.
 - Ensure storage areas are well-ventilated, secured, and inspected regularly.
- **Labels:**
 - Never remove or deface original manufacturer labels.
 - All secondary containers must be clearly labeled with the product identifier and hazard information.

- Labels will be maintained in good condition and replaced when damaged or unreadable.

8. Responsibilities

- **Management:** Maintain compliance with regulatory requirements, provide resources for SDS, training, and labeling.
- **Supervisors:** Ensure chemical inventories are up to date, SDS are available, employees are trained, and safe practices are followed.
- **Employees:** Follow safe handling and storage practices, wear required PPE, review SDS before use, and immediately report spills, leaks, or damaged labels.

9. Review and Updates

This policy will be reviewed annually and updated as necessary to reflect changes in chemical use, regulations, or workplace practices.

DRUG-FREE WORKPLACE PROGRAM FORM BID NO. 2026-01

In accordance with Section 287.087, State of Florida Statutes, preference shall be given to businesses with Drug-free Workplace Programs. Whenever two or more bids which are equal with respect to price, quality, and service are received for the procurement of commodities or contractual service, a bid received from a business that certifies that it has implemented a Drug-free Workplace Program shall be given preference in the award process. In the event that none of the tied vendors has a Drug-free Workplace program in effect, the City reserves the right to make final Decisions in the City's best interest. In order to have a Drug-free Workplace Program, a business shall:

1. Publish a statement notifying employees that the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance is prohibited in the workplace and specifying the actions that will be taken against employees for violations of such prohibition.
2. Inform employees about the dangers of drug abuse in the workplace, the business's policy of maintaining a drug-free workplace, any available drug counseling, rehabilitation, and employee assistance programs, and the penalties that may be imposed upon employees for drug abuse violations.
3. Give each employee engaged in providing the commodities or contractual services that are under bid a copy of the statement specified in subsection (1).
4. In the statement specified in subsection (1), notify employees that, as a condition of working on the commodities or contractual services that are under bid, the employee will abide by the terms of the statement and will notify the employer of any conviction of, or plea of guilty or nolo contendere to, any violation of Chapter 893, Florida Statutes, or of any controlled substance law of the United States of any State, for a violation occurring in the workplace no later than five (5) days after such conviction.
5. Impose a sanction on, or require the satisfactory participation in a drug abuse assistance or rehabilitation program if such is available in the employee's community by any employee who is convicted.
6. Make a good faith effort to continue to maintain a drug-free workplace through implementation. If bidder's company has a Drug-free Workplace Program, so certify below:

The material for the tubes is made of permeable polypropylene, filled with sand and organic matter, pumped hydraulically from the site's lake bottom, or if the sand is inadequate in quantity or quality, then sand is brought to the job site. Once filled and properly placed based on engineering specifications and depending on the number of tubes required, the EFT®s will endure for many years.

The implementation of our EFT® system makes the tubes ideal for many shoreline restoration situations. The flexibility of our EFT® allows the shape to conform to the flow of the original shoreline. The weight-filled tubes become a permanent structure providing strength for controlling future erosion and weight for soil stability. This process results in the ultimate goal of land reclamation for our clients.

The use of EFT® bypasses the need to bring heavy equipment to the job site, preventing the possibility of damage from the large weight of the equipment. By minimizing the use of heavy equipment, costs are lowered as well. The EFT® also allows for easily maneuvering through small areas and heavily wooded shorelines. Another advantage to using our EFT® to restore a shoreline: any type of plant, shrub, or ground cover is feasible. Once a project is completed and sod put down, hidden tubes allow for an aesthetically pleasing appearance.

Dewatering

EFT® systems for dewatering have proven themselves to be extremely efficient for containment and dewatering of pump slurry by-products, industrial waste, municipal sludge, pulp and paper sludge, and other marine sediments. They are custom manufactured in circumferences and lengths for each particular application with prefabricated filling ports and tie down straps along the length of the tubes. They will work well with any hydraulically transported material. The dewatering tubes are especially designed for the mechanical stresses associated with the filling and placement processes, including abrasion, tearing, puncturing, and flattening.

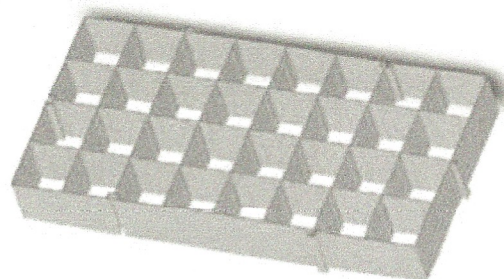


The Erosion Control Panel (ECP) is a patented restoration product and licensed to Landshore® exclusively for installation. The ECP stabilizes soils on shoreline embankments, creating a low-maintenance and structurally stable environment for long-term sustainability. The ECP is especially beneficial for non-cohesive granular infill materials. The ECP system minimizes erosion problems caused by water contact, surface flow and wave action.

At its core, the ECP has a cellular structure that improves resistance to erosion forces on steep, unstable ground or slopes exposed to severe hydraulic and mechanical stresses. The cellular confinement improves the performance of vegetated slopes by reinforcing root systems and directing hydraulic flows over the top of the cells. The cells therefore acts as a series of small 'check dams', preventing formation rills and gullies. It dissipates energy throughout and underneath the cells and confines the fill materials within the cells.

Typical installation consists of two panel sections centered at the main water table elevation. This reinforces the upper soil layer and resists erosive conditions as well as sliding forces beyond the limits of other systems. The ECP provides a long-term solution with sustainable vegetation and permeable aggregate. During water fluctuations, it offers better resistance to soil loss caused by saturation.
