

RESOLUTION NO. 2018-351

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA, AWARDING STANDBY/PRE-EVENT AGREEMENTS WITH GRUBBS EMERGENCY SERVICES, LLC.; BERGERON EMERGENCY SERVICES, INC.; AND CERES EMERGENCY SERVICES, INC., FOR REQUEST FOR PROPOSALS (RFP) 2018-016 - DISASTER DEBRIS MANAGEMENT SERVICES; AUTHORIZING THE CITY ADMINISTRATION TO TAKE APPROPRIATE ACTION TO EFFECTUATE THE INTENT OF THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Margate, Florida (the “City”), through Request for Proposal 2018-016 (“the RFP”), sought proposals from highly qualified Contractors with experience in the specialized management of disaster response labor, for the removal of debris along with the preparation, response, recovery, and mitigation phases of any emergency or disaster; and

WHEREAS, the RFP required Contractors to have the capability and ability to rapidly respond to wide-scale debris volumes typically produced in hurricanes, tornadoes, and other disaster types, as well as small-scale debris volumes; and

WHEREAS, the City desires to award contracts to two or more Contractors to insure adequate resources at the time of an event; and

WHEREAS, the City received nine (9) responses to the RFP , eight (8) firms were deemed to be responsive, and after final ranking and evaluation, City recommended an award of standby/pre-event agreements to the top three (3) ranked firms; and

WHEREAS, Staff recommends that such agreements have an initial term of five (5) years, with an option to renew for an additional five (5) year period. The proposed agreements provide for annual review in December of each year; and

WHEREAS, the City Commission of the City of Margate, Florida deems it to be in the best interest of the citizens and residents of the City of Margate to enter into agreements with the three top-ranked firms, (1) Grubbs Emergency Services, LLC. (Primary); (2) Bergeron Emergency Services, Inc., (Alternate); and (3) Ceres Emergency Services, Inc. (Alternate).

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF MARGATE, FLORIDA, THAT:**

Section 1. The foregoing "WHEREAS" clause is hereby ratified and confirmed as being true and correct and is hereby made a specific part of this Resolution.

Section 2. The City Commission of the City of Margate, Florida accepts the recommendation of staff to enter into separate agreements with (1) Grubbs Emergency Services, LLC. (Primary); (2) Bergeron Emergency Services, Inc., (Alternate); and (3) Ceres Emergency Services, Inc. (Alternate) (hereinafter "Contractors").

Section 3. The City Administration, including but not limited to the City Manager and City Attorney, is hereby authorized and directed to enter into separate agreements each Contractor.

Section 4. The City Administration, including but not limited to the City Manager and City Attorney, is hereby authorized and directed to take appropriate action to effectuate the intent of this Resolution.

Section 5. All Resolutions or parts of Resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.

Section 6. If any section, sentence, clause or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Resolution.

Section 7. This Resolution shall become effective immediately upon its passage and adoption.
