**MARGATE BOARD OF ADJUSTMENT
FINDINGS AND PROCEDURE FOR VIRTUAL PUBLIC MEETING**

The Margate Board of Adjustment (MBOA) is holding a virtual public hearing on Tuesday, July 14, 2020 at 6:30 p.m. This statement explains the MBOA's findings related to the need to hold the virtual public meeting, and the ability of the public to access the virtual public meeting.

The MBOA's findings and procedure for the virtual public meeting are as follows:

- Pursuant to Governor DeSantis' Executive Orders 20-51 and 20-52, in which the Governor declared a public health emergency and a state of emergency, there is a recommendation to limit public gatherings.
- On March 20, 2020, Governor DeSantis issued Executive Order 20-69, suspending the quorum requirements for public meetings held by a local government body, and the requirement that a local government body must meet at a specific public place.
- On June 23, 2020, Governor DeSantis issued Executive Order 20-150, extending Executive Order 20-69 regarding local government public meetings until 12:01 a.m. on August 1, 2020.
- Consistent with the authority contained in the Governor's Executive Orders, and in order to ensure the health, safety, and welfare of the MBOA's clients and employees, the v finds that it is in the best interest of the MBOA to hold this virtual public meeting.
