AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA, AMENDING CHAPTER 30 PERSONNEL, SECTION 30-23 "COVERED PERSONNEL"; TO PROVIDE FOR THE INCLUSION OF THE APPOINTED POLICE MAJOR POSITION AS A COVERED PERSONNEL POSITION FOR PURPOSES OF CIVIL SERVICE CODE PROTECTION; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on April 6, 2022, the City Commission approved Ordinance 2022-5, updating Chapter 30 - Personnel, of the Code of the City of Margate; and

WHEREAS, Ordinance 2022-5 excluded all ranks above the position of Police Captain as covered personnel under the civil service system of the City of Margate; and

WHEREAS, the City Commission desires to include the appointed position of Major as part of the civil service system, and to be covered by Article II - Civil Service of the City of Margate Code of Ordinances.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

**SECTION 1**: The Code of Ordinances of the City of Margate, Florida, Chapter 30 Personnel, Article II. Civil Service, Division 1. Generally. Section 30-23 - Covered personnel, is

- (a) All persons regularly employed by the City, except as hereinafter provided, are governed by this Article .
- The following positions are not governed by the rules (b) and ordinances of the civil service code: elected officials or persons appointed to fill vacancies in elected offices; the City Manager; the City Attorney; the City Clerk; any employee directly responsible to the City Manager, City Attorney, or City Clerk; directors of departments; assistant chiefs of the police department, all ranks in the police department above the classified position of police captain, excluding individuals appointed to the position of Major; any employee of the city whose salary and benefits are completely funded by the community redevelopment agency; temporary employees; part-time employees; independent contractors and all their employees or subcontractors or any employees paid from separately funded programs of the city other than the general fund and enterprise fund. Excluded employees shall include employees of the Northwest Focal Point Senior Center District.

c) Notwithstanding any other provision contained in this directive regarding appointments and employment, all other permanent employees of the City will be included hereunder.

(d) All employees will be employed, retained in employment and advanced to higher grades on merit and fitness only, except as hereinafter provided. Competitive examinations may be used where practicable to determine merit and fitness for initial employment and promotion. The City Manager may designate particular positions or particular kinds of positions that will not be subject to competitive examination.
