RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING THE PURCHASE OF VEHICLES AND EQUIPMENT FOR THE EXPANSION OF THE SPECIAL RESPONSE TEAM (SRT) AND K-9; AUTHORIZING WAIVING OF BIDDING FOR SOLE-SOURCE ACQUISITION OF VEHICLES OR EQUIPMENT, PROVIDING FOR CONTRACT PRICING SPECIALIZED EQUIPMENT; WITH THE ACQUISITION BEING FUNDED FROM POLICE IMPACT FEES AT A TOTAL COST NOT TO EXCEED \$925,000.00; PROVIDING FOR BUDGET AMENDMENT; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, Section 9-25 of the Code of the City of Margate, provides for imposition of police impact fees and the establishment of a police trust fund account; and

WHEREAS, Section 9-25(i) of the Code of the City of Margate provides that funds collected from police impact fees shall be used for the purpose of land acquisition and capital improvements to and expansion of police protection.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

<u>SECTION 1</u>: That the City Commission of the City of Margate, Florida approves the purchase of the following vehicles and equipment, utilizing police impact trust funds in an amount not to exceed \$925,000, to provide for expansion of police protection for the City of Margate:

- Terradyne Armored Rescue Vehicle not to exceed \$375,000.
 (SOLE SOURCE)
- Inkas Armored Sprinter Van not to exceed \$180,000 (GSA)*
- Flymotion (Spot) Robot with Articulating Arm not to exceed \$225,000 (SOLE SOURCE)
- Twenty Units, Peltor Comtac VI Headsets not to exceed \$20,000.
- Two Rifle Rated Ballistic Shields not to exceed \$12,000 (SOLE SOURCE)

- Ford F-150 K-9 Vehicle not to exceed \$74,500 (Enterprise Fleet Management Contract)
- Missing Person K-9 with ancillary equipment and training, not to exceed \$38,500

SECTION 2: That the City Commission of the City of Margate, Florida waiving of bidding for sole-source acquisition of certain vehicles and equipment, as noted above, and contract pricing for the remaining items.

SECTION 3: That the expenditures provided for in this Resolution shall be included in the next budget amendment for the fiscal year 2022 budget.

SECTION 3: That the Mayor and City Manager are authorized and directed to execute contracts for the above acquisition, and the administration is authorized to issue a purchase order and execute all associated documents in order to implement same.
