

Re: Preferences in Arkansas Procurement Law

#### Dear Saman:

You have inquired about the preferences granted by the law of the State of Arkansas in the letting of any or all public contracts. Based upon our review of the Arkansas Procurement Law, codified at Ark. Code Ann. § 19-11-201 et seq., we believe the statutes summarized below are responsive to your request. The following summary is qualified in its entirety by reference to the complete text of the statutes cited below, which are enclosed herein for your convenience and incorporated by reference in this letter.

Ark. Code Ann. § 19-11-259—Preference of Arkansas Firms. Pursuant to this section, except as prohibited by applicable federal law, in the purchase of commodities<sup>2</sup> by competitive bidding, all public agencies shall accept the lowest qualified bid from a firm resident in Arkansas, but only if (i) the bid does not exceed the lowest qualified bid from a nonresident firm by

more than five percent (5%) and (ii) one (1) or more firms resident in Arkansas made written claim for a preference at the time the bids were submitted. Please note that this section applies only to projects designed to provide utility needs of a county or municipality. See Ark. Code Ann. § 19-11-259(c)(1)(A).<sup>4</sup>

- 2. Ark. Code Ann. § 19-11-260—Recycled Paper Purchases—Goals. Pursuant to this section, with respect to the procurement of paper products, a preference for recycled paper products shall be exercised if the use of the products is technically feasible and the price does not exceed the lowest qualified bid of a vendor offering paper products manufactured or produced from virgin material by ten percent (10%). Please note an additional one percent (1%) preference shall be allowed from products containing the largest amount of postconsumer materials recovered within the State of Arkansas. Notwithstanding the foregoing, however, a bidder receiving a preference under this section shall not be entitled to an additional preference under § 19-11-259 discussed above.
- 3. Ark. Code Ann. § 19-11-305—Multiple Private Industry Bids. Subject to any applicable bonding requirements, in all bidding procedures involving a bid by one (1) or more out-of-state penal institutions<sup>5</sup> and a bid by one (1) or more private industries located within the State of Arkansas, the contract shall be awarded to the sole Arkansas bidder or lowest Arkansas bidder if the Arkansas bidder is not underbid by more than five percent (5%), as provided in § 19-11-259, by another representative of private industry located outside the State of Arkansas or by more than fifteen percent (15%) by an out-of-state correctional institution.


