A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING THE WAIVER OF BIDDING REQUIREMENTS, AND TO AUTHORIZE THE SOLE-SOURCE ACQUISITION OF AUTOMATIC LICENSE PLATE RECOGNITION (ALPR) CAMERAS AND VEHICLE FINGERPRINT SYSTEM, PURSUANT TO AN AGREEMENT WITH FLOCK GROUP, INC.; AUTHORIZING THE USE OF FUNDS FROM THE LAW ENFORCEMENT TRUST FUND (FEDERAL) AT A COST NOT TO EXCEED \$48,400.00 FOR THE FIRST YEAR AND \$43,500.00 FOR THE SECOND YEAR; PROVIDING FOR TWENTY-FOUR (24) MONTH INITIAL AND RENEWAL TERMS; PROVIDING FOR EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate, Florida approves the waiver of bidding requirements, and authorizing the sole-source acquisition of Automatic License Plate Recognition (ALPR) Cameras and Vehicle Fingerprint System from Flock Group, Inc. (hereinafter "Flock Safety"). Authorizing the use of funds from the Federal Law Enforcement Trust Fund, in an amount not to exceed \$48,400.00 for the first year and \$43,500.00 for the second year of the initial term.

SECTION 2: That the expenditure is deemed to be in the best interest of the City of Margate.

SECTION 3: The Chief of Police recommends the expenditure in Federal Law Enforcement Trust Funds ("LETFs") for purchase of the Flock Safety Automatic License Plate Recognition (ALPR) Cameras and Vehicle Fingerprint System for the Police Department.

SECTION 4: The Chief of Police certifies the expenditure in LETFs for the Flock Safety Automatic License Plate Recognition (ALPR) Cameras and Vehicle Fingerprint System for the Police Department, in that the funds will be used for an appropriate law enforcement purpose.

SECTION 5: The Chief of Police certifies the

expenditure in LETFs for the Flock Safety Automatic License Plate Recognition (ALPR) Cameras and Vehicle Fingerprint System for the Police Department, in that the funds are not being used as a normal source of revenue for the Police Department.

SECTION 6: The Chief of Police certifies the expenditure in LETFs for the Flock Safety Automatic License Plate Recognition (ALPR) Cameras and Vehicle Fingerprint System for the Police Department in that the funds were not considered in the adoption and approval of the Police Department budget.

SECTION 7: That the Mayor and City Manager are authorized and directed to execute the Agreement for the above acquisition, and the administration is authorized to issue a purchase order and execute all associated documents in order to implement the purpose and intent of this Resolution.

SECTION 8: That this Resolution shall become effective immediately upon its passage.
