8) DISCUSSION AND POSSIBLE ACTION

A. <u>ID 2022-400</u> DISCUSSION AND POSSIBLE ACTION - MAYOR'S CHOICE FOR MARGATE EMPLOYEE OF THE YEAR.

MAYOR ANTONIO V. ARSERIO explained his choice for selecting the Employee of the Year which was awarded to the Building Department's Lead Permit Specialist, April L. Buddie.

DIRECTOR OF BUILDING, RICHARD R. NIXON, read a statement on Lead Permit Specialist Buddie's achievements.

Discussion ensued.

B. <u>ID 2022-445</u> SPECIAL EVENTS FUNDING/DONATION REQUEST PROGRAM - WOMEN IN DISTRESS OF BROWARD COUNTY, INC.

A motion was made by Vice Mayor Caggiano, seconded by Commissioner Schwartz, to approve this Item.

COMMISSIONER ARLENE R. SCHWARTZ said that as this was a line item in the Budget, she asked if it needed to appear annually.

CITY MANAGER CALE CURTIS confirmed that if that was the wish of the City Commission, this could be a line item in the budget for 2024.

Discussion ensued.

BROWARD COUNTY GRANTS MANAGER AND WOMEN IN DISTRESS OF BROWARD COUNTY, SUSAN EVANS, provided an update on her organization and referenced survivors of domestic abuse.

A question and answer session ensued between the City Commission and Ms. Evans.

JONATHAN A. KRALJIC, 7357 FLORES WAY, said that the City was very generous to consider \$1,000 for this charity but believed that the amount should be higher.

TINA N.TOEPFER, 6704 NW 28TH CT, complained about mold at Margate Middle School and referenced the City Commission receiving \$5,000 bonuses.

TRACY VAN WINKLE, 1020 SW 61ST AVENUE, highlighted all formats of abuse.

C. ID 2022-462

DISCUSSION OF A SPONSORSHIP OPPORTUNITY FOR THE CITY OF MARGATE TO SPONSOR A BASEBALL TOURNAMENT HOSTED BY THE MARGATE LEGACY ELITE TRAVEL BASEBALL TEAM LOCATED AT CITY FACILITIES.

CITY MANAGER, CALE CURTIS, informed that The Margate Legacy Elite organization was putting together a Winter baseball tournament at Margate Sports Complex and at Vinson Park Field in December. He asked the City Commission to consider being a partner in this tournament where the City would provide the fields rent-free and then the organization would pay for their labor fees for lining and dragging the field between games. He said that the estimated total which included the rental fees and labor costs would be \$7,000. He also advised that the labor fees were estimated to be approximately \$2,600. He indicated that sports tournaments brought in a number of teams from around the State and from other cities into Margate, it also provided a local benefit and said that there would be a nexus in providing a sponsorship for this event.

A motion was made by Commissioner Ruzzano, seconded by Mayor Arserio, to waive the fees for this Item.

COMMISSIONER TOMMY RUZZANO explained that the Baseball league was in partnership with the City and provided further information in support of this Item.

COMMISSIONER JOANNE SIMONE explained why she was against waiving the fees for this Item.

Discussion ensued.

JULIE JONES questioned how long the tournament would be. She indicated that it would bring revenue into the City and believed in a fifty percent partnership.

ELSA J. SANCHEZ, 6930 NW 15TH STREET, did not agree in waiving fees for this Item as she believed that it was unfair to the residents.

MR. KRALJIC did not agree with the City waiving fees for events.

DALE R. CLARK, 5146 NW 58TH TERRACE, CORAL SPRINGS, thanked the City for considering this Item and discussed baseball tournaments.

Discussion ensued.

PARKS AND RECREATION DIRECTOR, MICHAEL A. JONES, discussed the field rental fees

2) PUBLIC DISCUSSION

Anyone wishing to comment on any item on the Consent Agenda should approach the podium now. Each speaker is limited to three (3) minutes.

MAYOR ARSERIO explained the protocol for submitting comments to Public Discussion which included the Consent Agenda.

MR. KRALJIC read a statement on the nomination of a City Mayor.

MS. TOEPFER voiced her concerns about matters pertaining to the City and highlighted the conditions of Margate schools.

MS. SANCHEZ congratulated Mayor Arserio and Commissioner Simone on their re-election. She read a statement seeking consideration to elect Commissioner Simone as Vice Mayor at the next City Commission meeting.

MS. VAN WINKLE highlighted the behavior of the City Commission towards residents.

JULIE JONES referenced the recent elections and suggested that changes needed to be made in the City. She sought an update on the Glindmeier property.

INTERIM CITY ATTORNEY, DAVID N. TOLCES, provided an update on the Glindmeier case.

3) COMMISSION COMMENTS

COMMISSIONER SIMONE congratulated all employees and highlighted their value to the City. She read a statement expressing her gratitude towards her "true blue" loyal supporters pertaining to the election. She encouraged people to visit Broward Meat and Fish Co. and the Holy Cow Ice Cream shop. She requested if the City could place a box in the lobby to collect clothing and household goods for the Margate Nursing Home.

CONSENSUS was provided by the City Commission to put a box in the lobby.

COMMISSIONER SCHWARTZ congratulated both Mayor Arserio and Commissioner Simone on their re-election. She discussed her visit to Broward Meat and Fish and reminded that the WinterFest was on December 16th. She advised that Women in Distress should ask for a different amount of money to be added during budget time. She referenced the mold and informed that the City of Margate was not the Broward County School system.

VICE MAYOR ANTHONY N. CAGGIANO highlighted that the City paid for a second School Resource Officer (SRO) in every school.

COMMISSIONER SCHWARTZ discussed SROs. She explained the City Commissioner's pay rises.

COMMISSIONER RUZZANO congratulated Mayor Arserio and Commissioner Simone on their re-election. He highlighted that Margate paid the highest amount for this election.

COMMISSIONER SCHWARTZ discussed the increase in the cost of the election and the voter registration card containing incorrect precinct information.

COMMISSIONER RUZZANO highlighted the problems which occurred during the Election and at the polling stations and referenced the City possibly writing a letter to Broward County Supervisor of Elections, Joe Scott.

Discussion ensued on the elections.

COMMISSIONER RUZZANO discussed the City's logo and tag line and said that he wished to revert to the previous seal. He referenced property prices increasing.

VICE MAYOR CAGGIANO wished everyone a Happy Thanksgiving and said that they should be safe.

MAYOR ARSERIO congratulated Commissioner Simone on her re-election and also thanked the two other candidates who also did a good job. He thanked his supporters and discussed that it passed for residents to vote on the Mayor elect. He wished the future City Mayor all the best and discussed people moving in and out of the City.

4) CITY MANAGER'S REPORT

CITY MANAGER CURTIS congratulated Commissioner Simone and Mayor Arserio on their re-elections and looked forward to working with them during the next four years. He announced that today, they had suspended the application portal for the Property Improvement Grant Program (PIP). He continued to provide an update on the PIP information and said that so far, it had been a tremendous success. He informed that they had received over 250 applications totaling more than \$2,300,000 and 35 applicants had been approved to date for approximately \$180,000.

COMMISSIONER SCHWARTZ suggested that they should remind people that it was a reimbursement program as opposed to grants.

INTERIM CITY ATTORNEY TOLCES congratulated Commissioner Simone and Mayor Arserio on their reelection and he looked forward to continuing to work with them.

CITY CLERK JENNIFER M. JOHNSON congratulated Commissioner Simone and Mayor Arserio.

[Appendix A – Zoning – Section 3.3] Any representation made before any City Board, any Administrative Board, or the City Commission in the application for a variance, special exception, conditional use or request for any other permit shall be deemed a condition of the granting of the permit. Should any representation be false or should said representation not be continued as represented, same shall be deemed a violation of the permit and a violation of this section.
