1) CALL MEETING TO ORDER

The Regular meeting of the Margate Employees Benefit Trust Fund (MEBTF) was called to order at 2:32 p.m. by Acting Chair Joanne Simone.

2) ROLL CALL

Attendance was noted by roll call.

3) PUBLIC DISCUSSION

There was no public discussion.

4) MOTION APPROVING MINUTES OF DECEMBER 12, 2013

MOTION: SO MOVE TO APPROVE.

The motion was approved by a unanimous vote of 5-0.

5) APPROVAL OF INVOICE

6) APPROVAL OF BENEFIT APPLICATIONS FOR 2014

MOTION: SO MOVE TO APPROVE PAYMENT OF DEATH BENEFIT FOR MICHAEL SCAPERROTTA.

<u>Efrain Suarez</u> explained that Mr. Scaperrotta passed away in December; therefore, his beneficiary would receive the full benefit.

<u>Jackie Chin-Kidd</u> explained the calculation and believed that the benefit was for 12 months and the amount of how many months were previously overpaid was deducted, but she would review the Charter to make certain.

Mr. Suarez further explained that because MEBTF prepaid, the beneficiary was entitled to the full year's death benefit.

The motion was approved by a unanimous vote of 5-0.

7) REPORT FROM ATTORNEY

There was no Attorney present.

8) REPORT FROM TRUSTEES

<u>Jackie Chin-Kidd</u> mentioned Eugene Woolever and said that it was decided he did not pay anything; therefore, he would not receive a check.

<u>Mark Weinrub</u> said that he spoke with Mr. Woolever who sent his Social Security form indicating the amount taken out for Medicare; however, nothing had been deducted. He stated that Mr. Woolever was not paying a medical premium for insurance; therefore, he was not eligible to receive a check. He added that Mr. Woolever understood.
