NAORDINANCE OF THE CITY MARGATE, OF AMENDING 2-73 FLORIDA, SECTION APPOINTMENT PROCEDURES FOR BOARDS AND COMMITTEES; PROVIDING FOR APPOINTMENT AND APPLICATION PROCEDURES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

Section 1: Chapter 2 Administration, Article IV Boards, Committees, etc., Division I Generally, Section 2-73 is hereby amended to read as follows:

Sec. 2-73. - Appointment and application procedures for boards and committees.

A. Appointment Procedures

- (1) All Boards and Committees of the City of Margate shall be appointed by majority vote of the City Commission utilizing the procedure provided in subsection B. below.
- (a) (2) Simultaneous with the second commission meeting in March January 2013, the term of each individual sitting on any board or committee of the City of Margate shall be deemed to have expired.
- (b) (3) At the second city commission meeting in March January 2013, and every year thereafter each commissionerthe City Commission of the City of Margate shall make one (1) appointments to each of the boards and committees shall appoint five (5) members of each City board for a term of one year.

CODING: Words in struck through type are deletions from existing text; Words in underscored type are additions.

- (c) At the second city commission meeting in January 2013, in which there are existing vacancies pursuant to paragraph (a). The city commission shall ratify each commissioner's appointment.
- (d) The term of each board member or committee member appointed pursuant to paragraph (b) shall expire simultaneous with the first commission meeting in January 2015.
- (e) At the first commission meeting in January 2017 2015, each board member or committee member shall be appointed or reappointed, as provided in paragraph (b) above, for a term which shall expire upon the appointment of a successor at the first meeting of January 2017.
- (f) All subsequent board or committee members shall be appointed at two year intervals by the procedure provided in paragraphs (a) through (d) above.
- (4) Upon a vacancy of any board or committee, prior to the full term of any board member or committee member, a vacancy shall be filled as provided in section B. by selection of the commissioner (or successor to the seat of the commissioner) who had appointed the board member or committee member who vacated that position. The selection shall be ratified by the city commission within thirty (30) days of the vacancy.
- (g) (5) Exempted from the above shall be any board or committee appointed by the administration or composed solely of city-employed staff, or any board or committee appointed or elected as provided for by federal law, state statute or the Charter of the City

of Margate; the Community Redevelopment Agency Board of the City of Margate; the Board of the Northwest Focal Point Senior Center District; or the Recreation Foundation.

(6) Temporary boards or committees that are formed by resolution of the City Commission shall also be exempt from this ordinance.

B. Application Procedures

- 1) Individuals wishing to be considered for any vacancy on any board or committee, shall submit an application to the Office of the City Clerk not later than fourteen (14) days prior to the meeting in which the City Commission shall fill said vacancy. The application shall include a request for qualification specific to the board or committee to which the individual is applying.
- 2) <u>Incumbents</u> who wish to be considered for reappointment to a particular board must comply with the preceding subsection.
- 3) Applications shall not be considered for any applicant to any board or committee which was submitted more than two years prior to the date which an applicant could be appointed.

 $\underline{\tt SECTION~2:}$ All ordinances or parts of ordinances in conflict herewith are and the same is hereby repealed to the extent of such conflict.

SECTION 3: If any section, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this ordinance.
