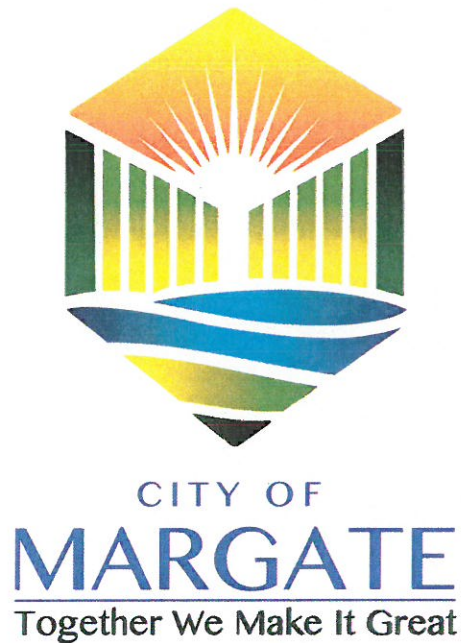

Soil Tech Distributors, Inc., is part of a Miami based family of companies with extensive trucking experience. Soil Tech and its sister companies, Bulk Express Transport and Intercity Disposal, are primarily engaged in the businesses of hauling rock, soils, sand and gravel, municipal solid wastes, construction and demolition debris, recyclable materials, ash, sludge, and wood by-products throughout Florida. Another related company, Rabsa, collects municipal solid waste under municipal contracts in the San Jose, Costa Rica metropolitan area. The Costa Rica business also includes the operation of a regional solid waste landfill.

The group's main office and trucking terminal is in Miami, but additional facilities exist in Tampa and Orlando. The Costa Rica operations are headquartered in Alajuela, a suburb of San Jose. The family of companies together comprises a privately owned trucking organization possessing over 300 tractors and trailers, dump trucks, loaders and excavators, and solid waste collection vehicles. Independent contractors working for the companies contribute another 250 dump trucks, tractors and trailers to the organization's physical asset base. This substantial investment in equipment makes the organization uniquely qualified to provide high quality and reliable transportation services to Florida's various heavy industries and local governments.
