<u>Douglas E. Smith</u>, Executive Director, commented that there was a discussion about holding a Trunk or Treat event at the previous CRA meeting and that he had some additional information to share on events. He said the Pet Expo event would be held on CRA property as well as an upcoming CRA event planned for November. He said the event, Celebrate Margate, would be held on November 15, 2014 from 10:00 a.m. to 5:00 p.m. and it would include local vendors, restaurants, businesses, community demonstrations, etc. He said it would be the community brand launch event and promotional information would be forthcoming. Mr. Smith asked if the Board still wished to proceed with the Trunk or Treat event in addition to the two other events. He said he spoke with the police chief who recommended that a couple of police officers be present because there was not much pedestrian traffic in this area, noting that people also went to mall and church venues. He said he also spoke with the director of Parks and Recreation who said that trick or treating in the community was popular here.
