ORDINANCE NO. _____

AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA, ADOPTING AN OPERATING BUDGET FOR THE CITY OF MARGATE, FLORIDA, FOR THE PERIOD BEGINNING OCTOBER 1, 2015, AND ENDING SEPTEMBER 30, 2016; PROVIDING FOR A BUDGET FOR THE GENERAL FUND, SPECIAL REVENUE FUNDS, DEBT SERVICE FUND, CAPITAL IMPROVEMENTS FUND, ENTERPRISE FUNDS, AND INTERNAL SERVICE FUND; PROVIDING FOR A MILLAGE RATE; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to the City Charter of the City of Margate, Florida, and the State Law, a proposed budget of the estimated revenues and expenses for the fiscal year 2015/2016 has been prepared and reviewed; and

WHEREAS, after review of same, the City Commission does hereby approve same and desires to adopt said budget;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the foregoing Preamble is hereby ratified and confirmed as true and correct by the City Commission of the City of Margate, Florida.

SECTION 2: That there is hereby adopted a budget for the 2015/2016 fiscal year for the City of Margate for the period beginning October 1, 2015, and ending September 30, 2016. A copy of said budget is attached hereto and specifically made a part of this ordinance.

SECTION 3: That a complete copy of the entire budget for the 2015/2016 fiscal year of estimated revenues and expenses is available in the City Clerk's Office, along with any amendments thereto made by the Margate City Commission on the dates of public hearings.

2 SECTION 4: That the budget shall automatically be
3 adjusted for any federal, state or county grant for which
4 the City Commission has approved the acceptance thereof.

6 SECTION 5: That the budget shall automatically be
7 adjusted for any outstanding encumbrances as evidenced by an
8 authorized purchase order, or a formal commitment by the
9 City Commission, issued prior to the end of the fiscal year.

11 SECTION 6: That the ad valorem tax rate of the City of
12 Margate shall be that as determined by the City Commission,
13 pursuant to state law.

15 SECTION 7: That all ordinances or parts of ordinances
16 in conflict herewith be and the same are hereby repealed to
17 the extent of such conflict.

19 SECTION 8: That if any section, sentence, clause, or
20 phrase of this ordinance is held to be invalid or
21 unconstitutional by a court of competent jurisdiction, then
22 said holding shall in no way affect the validity of the
23 remaining portions of this ordinance.

25 SECTION 9: That this ordinance shall become effective
26 on October 1, 2015.
