Reference: Towing Services – RFP 2010-001

At our recent meeting, you expressed a desire to renew the above referenced contract which expires September 21, 2015. There is one final five (5) year renewal option remaining on the contract.

It is our intent to bring the renewal of this contract before our City Commission for consideration at the September 16, 2015 meeting. As we discussed, if approved, the contract extension will be under the same terms, conditions and specifications as outlined in RFP 2010-001 and City Resolution No. 11-756, with the exception of two (2) rate adjustments to the outside and inside storage rates for Class "C" tows. These rate adjustments shall be decreases necessary to comply with Broward County Resolution No. 20150-051, which sets the maximum allowable rates for such services.

You will find an attached copy of the rate schedule submitted by your company in response to our original Request for Proposals. The rates for outside and inside storage of Class "C" tows have been stricken through and the adjusted rates have been added. If you agree with the adjusted rates, and wish to renew the contract, please initial on the line next to each adjusted rate.



MARGATE FOR AN ANNUAL SERVICE FEE PAYABLE TO
THE CITY OF \$52,000

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF
MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City
of Margate awards RFP No. 2010-001 approving contract with J & J
Towing, Inc. to provide towing services for the City of Margate
for an initial period of five (5) years with an option to renew
for an additional five (5) year period. In addition City shall
receive a service fee of \$52,000 annually payable in twelve (12)
monthly installments of \$4, 333.33.

authorized and directed to execute a contract for the award of
RFP Towing Services to J & J Towing, Inc.
